BLOCKS OCEAN COMMERCE.

How It Has Set the Pacific Mail Against the Management of the Panama Railroad.

NEW YORK, Feb. 16.—Negotiations between the Panama Railroad Company and the Pacific Mail Steamship Company looking toward an agreement upon some contracts by which the two companies can cooperate have been pending for over a week.

A reply came last evening from the Pacific Mail Company to the Panama Company which amounts to a complete failure of the negotiations, but which gives the Panama officials some reason to believe in the future possibility of an arrangement being made acceptable to both parties.

The contract which was refused last evening was prepared by the Panama directors at their meeting on Saturday last. A favorable answer was expected, and the refusal was a surprise.

The contract was essentially those of the Panama Company's offer of last January. They give the Panama people the right to determine the tariff on through freight and name or dismiss agents having the execution of through bills of lading.

Secretary Oppenheimer of the Panama Company said this evening, however, that the companies are on better terms than ever before, and that they feel now that in the future the Panama Company and the Pacific Mail Company will be acting together on terms beneficial to both, and to transcontinental commerce generally.

Speaking of the pending negotiations with Traffic Manager Leis, Mr. Oppenheimer says: "We are still in conference with Leis. Nothing has yet been definitely settled, but the prospect is entirely favorable for a successful outcome. We do not differ in any way on the principle involved; it is simply on the details, which we are going over carefully. Of course no one can tell what objections may arise, but I see nothing of importance now standing in the way. As soon as an agreement is reached it will be given out at once to the press."

Carlisle Denies It. He is Not in Favor of the Issue of Bonds.

WASHINGTON, Feb. 16.—Senator Carlisle was asked today what authority there was for the statement credited to him that one of his first bills would be to issue bonds, and he said that he would be followed by a special session of Congress, at which the Sherman act would be repealed.

There is a new plan on foot to get a vote on the suspension of silver purchases. It consists in obtaining a special order from the committee on Rules for the consideration of the Sherman act, which would be passed the Senate last summer, and then moving the substitute suspending the further purchases of bullion under the Sherman law until the bullion in the treasury is exhausted.

New York, Feb. 16.—The Washington correspondent of the Tribune says: "It is learned that the President before leaving Washington yesterday left Secretary Foster with instructions to use his own discretion in the matter of issuing bonds. In other words, the President, who up to yesterday was firmly resolved not to permit the issue of bonds while he remained in office, has now decided to reach the conclusion that he should become evident that the parity between gold and silver dollars cannot longer be maintained, it will be better to resort to the issue of bonds than to permit the \$100,000,000 reserve to be attacked."
