WHY THEY WANT HUBBELL NOMINATED

The Business Interests of New Mexico are Anxious to Have Frank A. Hubbell Sent to the U. S. Senate

BURSUM WILL BE REPUBLICAN NOMINEE FOR GOVERNOR

The Magdalena News is undoubtedly on the right track when it says the movement for the nomination of Hon. Frank A. Hubbell is being encouraged by the business interests of the state, and more particularly the live-stock interests, which are so closely connected with the agricultural interests of the state because of the development of the feeding industry.

The News calls attention to the fact that the live stock interests of the nation have been fighting for years to break the strangle hold of the meat packers on both the buying and selling markets of the nation and that the fight has now been taken into congress, where the live stock growers have gone asking for a congressional investigation of the packers and their methods.

When it is considered that the protection of the live stock interests of this state means the protection of the largest taxpayer interests with the exception of the railroads, it can be understood that thousands of the most substantial citizens of the state must be closely identified with any movement for its protection or advancement, and that the success of the live stock growers will soon be closely identified with those thousands who will go into the feeding of live stock, it is not hard to understand the movement towards Hubbell, who is heavily interested in sheep, cattle, ranches, farming, banking and almost every other real interest of the state.

BURSUM WILL BE NOMINATED

Mr. Bursum is practically assured of the republican nomination for governor. Even the Albuquerque Journal, a paper that can hardly be accused of being partial to him, estimates that he will have a good safe majority over all competitors in the state convention. The probability that Mr. Bursum will be elected is equally strong. He was beaten for the governorship at the first state election, to be sure, but political conditions in the commonwealth have changed radically since then. At least ninety per cent of the several thousand progressive votes that were cast against him years ago will be cast for him at the approaching election and, besides, at least two strongly republican counties that went over into the democratic column because of factional differences are now normal again and will give the old time majorities for the republican ticket. H. O. Bursum will be our next governor and he will give the state a wise and beneficent administration.—Socorro Chieftain

A. J. ROLLAND FOR TREASURER

In another column of this issue will be found the announcement of A. J. Rolland as a candidate for Treasurer of Lincoln County, subject to the decision of the Republican Party.

Mr. Rolland was born in the state of Michigan, December 3, 1881 and obtained his education at the public schools of that state, graduating at the Fenton High School in the year 1898. He lived in Detroit for a number of years and spent one year in Chicago, where he was engaged in various lines of business. Mr. Rolland came to New Mexico thirteen years ago and located at Alamogordo where he and his brother engaged in the drug business. In 1906 Rolland Bros. established a drug store at Carrizozo with A. J. Rolland in charge of the business. He has since been a resident of Lincoln County and is regarded as one of the county's most substantial business men, still being engaged in the drug business.

A few years ago he was appointed a member of the Board of Trustees of the New Mexico Institute for the Blind at Alamogordo which office he is still holding, and was at one time postmaster at Carrizozo. He is a member of the order of Odd Fellows, being a Past Grand Master of the local lodge. He is also a member of the Elks, his membership being with the El Paso lodge.

Mr. Rolland being a life long republican, has always taken an active part in politics and has always stood ready to render what ever assistance he could for the benefit of his party, although he has never before asked for an office. On account of Mr. Rolland's business ability, his business interests, his good citizenship, he is a man in whom the people of Lincoln County may depend upon to look after the affairs of this important office, to the satisfaction of the tax payers, in case he is elected.

Aged Pioneer of Lincoln County Passes Away at His Home in Capitan After a Brief Illness

Last Sunday morning at the hour of six o'clock, Seborn T. Gray, a pioneer of Lincoln County, passed away at his home in Capitan after a brief illness lasting only a few days. Death was due to paralysis from which the deceased had suffered much in the past several years.

Mr. Gray was born in Alabama in 1845, and moved with his parents to Louisiana where he remained until a young man. He came to Lincoln County in the year of 1885 and had resided here continuously up until the time of his death. During the 31 years spent in this county Mr. Gray had been engaged in various lines of business and made a fair success of his undertakings. In his earlier days Mr. Gray took an active part in politics and was one time county superintendent of school of Lincoln County.

He was married in 1871 to Miss Sarah Glenn. To this union were born six children, five of whom survive. They are: Walter, Seborn, Gordon and Mrs. Beulah Williamson, and Mrs. Wm. M. Reilly who lives in this city. The deceased is also survived by his aged wife and several grandchildren.

Funeral services were held at Capitan Sunday afternoon which were attended by a large number of relatives and friends, there being many from Carrizozo present. Interment was made in the Capitan Cemetery.

Not only in death of Mr. Gray did his family suffer an irreparable loss, but a host of friends throughout the county as well. He was a good husband, a kind and loving father, a good neighbor, and was always ready to help a friend in need.

THE NEW MEXICO STATE FAIR

New Mexico's State Fair Which Will be Held This Fall at Albuquerque Will Surpass all Previous Ones

LINCOLN COUNTY SHOULD TRY FOR THE \$1,000 PRIZE

The first real State fair ever held in New Mexico was that of last year. From all over the state come reports of a greater fair this year than last.

W. P. Southard, president of the fair board, and M. L. Fox, of the Albuquerque Morning Journal, were in Carrizozo Wednesday and arranged for a meeting of the county commissioners and of citizens of Lincoln county to be held in the court house, at Carrizozo, at 2 p. m. Monday, August 7.

Mr. Southard called upon governor McDonald who agreed to be present and Mr. Southard will be with him.

It is believed that arrangements will be made to go after the first prize of 1,000. Lincoln county has the varieties of production and excellence of quality which is sure success, if sufficient interest is aroused and the co-operation of the citizens is secured.

Another feature to be considered is the agricultural congress at El Paso just after the New Mexico fair closes at Albuquerque. Mr. Southard believes it quite possible for New Mexico to make a state exhibit there that will come close to first prize against more than twenty other state contestants. By selecting from the best of the exhibits brought in from New Mexico counties, a splendid exhibit can be made by the state at El Paso at very small expense.

PHEASANTS FOR COUNTY

Ed Kelley has just received from the state game warden at Santa Fe, four young Chinese, (ringed necked) pheasants which he intends to turn loose on the range for the purpose of stocking the country, which would certainly do greatly to the sportsmen's pleasure. Mr. Kelley's brother who is here visiting from Idaho says these birds are plentiful in his state and expresses the opinion that this country could well expect more favorable results from the pheasants than any of the northwestern states.

It is hoped that when these birds are turned loose that every member of gun clubs and sportsmen throughout the county will lend their co-operation in their protection.
