PROPOSED CHARTER

ARTICLE ONE

Name and place of business.

Sec. 1. The name of the corporation shall be The Union Investment Company.

Sec. 2. The said corporation shall be located and have its principal place of business in the city of Live Oak, Suwannee county, Florida, and for the purpose of carrying out the purposes of the business of the corporation, it shall have the power to establish branch offices at any other point or points within the State of Florida.

ARTICLE TWO

General nature of the business to be transacted by the corporation.

Sec. 1. The general nature of the business to be transacted by the corporation shall be to deal in all kinds of real estate, to buy, sell, lease and sub-lease all kinds of real estate; to buy and sell all kinds of timber, or to sell sawmill, crockery, turpentine or wood privileges on land; to manufacture and sell lumber, crossties, turpentine and rosin, wood, hardwood and furniture; to improve real property in any manner in which the corporation shall see fit; to own, buy, sell, lease or hold property and also farms and farm land; to buy, sell and hold personal property and chattels of all kinds; to engage in general mercantile business if desired; to be and become agents for life, fire or accident insurance for any company authorized to do business in the State of Florida; to buy and hold stock in other corporations; to own and keep a system of title abstract books and engage in the abstract business.

Sec. 2. The corporation shall have the power to issue bonds on such terms and conditions as its directors may deem proper and is authorized to issue its first mortgage or deed of trust on all or any of its assets to secure the same. The corporation shall also have the right to deal in stocks and bonds, judgments and decrees, to deal in notes and mortgages and all evidences of indebtedness; to lend or borrow money in its corporate capacity; to contract and be contracted with and to sue and be sued in its corporate name, and shall have power to do all those things incident to corporations of this kind under the laws of the State of Florida.
