A BIG MAJORITY

In Alabama against the Prohibition Amendment to Constitution.

Birmingham, Ala., Nov. 30.—The electors of Alabama yesterday declined to embody prohibition in the organic law of the State, as they rejected the constitutional amendment prepared and submitted by the last legislature.

The opponents of the amendment won the victory by a majority exceeding 23,000, and the result is accepted generally as a rebuke to Gov. Comer, who has been an intense radical in his leadership of the prohibition forces.

It is agreed that the result of yesterday's election will cause a modification of the present drastic temperance laws when the legislature meets, although it is not expected that they will be repealed.

The large towns went heavily against the amendment, while many of the country precincts voted in favor of it.
