SLAYER BURTON IS OUT ON BAIL.

Man Who Killed Wishart at San Antonio, Pasco County, Allowed Liberty.

A letter to State Attorney Phillips from County Judge Wallace, of Pasco county, states that Judge Wallace has admitted Burton, the man who shot and killed Wishart, at San Antonio, mistaking him for Dr. Nobles, a dentist, to bail in the sum of \$5,000. Burton waived a preliminary hearing.

State Attorney Phillips expressed himself to a Tribune man as somewhat surprised at the admitting of Burton to bail, considering the facts in the case, as reported to him. Burton, it appears, having some grievance against Nobles, shot at Nobles through a window of his dental office, killing Wishart, who was there having some dental work done for his daughter. The immunity given murderers in this State is becoming a very serious matter.—Tampa Tribune.
