

### CONSTITUTIONALITY OF BUCKMAN BILL

To Be Attacked in the State Courts.

FIGHT NOW ON TO THE FINISH

Lake City People Mad Because State Board of Education Would Not Donate Entire Equipment of University. Refusal to Admit Student Ground.

The following appears in The Times-Union of 17th inst. under a Tallahassee date line:

"Judge Arch Henry of Lake City is here in consultation with Attorney-General Ellis. The citizens of Lake City, whom he represents, will probably institute legal proceedings to test the constitutionality of the Buckman bill.

"The refusal of the State Board of Education to convey the equipment of the University of Florida, as agreed at a meeting of the joint boards, July 24, is the cause of great dissatisfaction."

It has been understood by the people of Gainesville for some time that the Lake City people would contest the constitutionality of the Buckman Bill, their pretext for doing so being the refusal of President Sledde of the State University to admit a student who was not qualified under the provisions of the Buckman law.

The fight cannot commence too soon to suit the people of Gainesville, all of whom are anxious to have the question settled. The people of Lake City, that is the masses, are also equally anxious for a final settlement of the constitutionality of the law, and it is to be hoped that Judge Henry will no longer delay the instituting of legal proceedings in the matter, for no one at all acquainted with the situation ever doubted that it was the intention of certain Lake Cityites to do otherwise from the moment they were caught in the trap which they had set for Gainesville, Bartow, Tallahassee and DeFuniak.

Should the courts decide the law unconstitutional the various State schools would remain as they were prior to passage of the Buckman Bill, except that there would be no available funds with which to conduct them, and Governor Broward would face the alternative of depriving the children of Florida of the advantages of higher education for two years, or calling an extra session of the Legislature to make appropriation for operating the University and other State schools.
