

## HOLLOWAY CASE IS NOW ON IN COURT

All of Wednesday Afternoon Was Spent Trying to Secure Jury.

FIVE HAVE BEEN SELECTED

By Order of Court a Special Venire of Twenty Was Drawn From Box and Case Will be Resumed Today—Other Transactions of the Court.

The principal business to come before the circuit court Wednesday was the case of the State vs. William M. Holloway, charged with criminal libel. The case was originally set for 9 o'clock in the morning, but at the convening of the court was postponed until 2 o'clock.

Promptly at that hour the docket was sounded, and all parties announced ready for trial. The court room was not unusually crowded, as was expected would be the case, which was evidence of the fact that this famous case had lost the original interest which it commanded.

The afternoon was spent in securing a jury, and only five were selected. The panel having become exhausted, the sheriff and clerk, by order of the court, drew from the box a special venire of twenty names for this case, as follows:


