

NEWS FROM ALL PARTS OF FLORIDA

The Bonifay Lumber Company will have their new plant ready for business on October 1st.

The Leonia school has been vacated for two weeks and the pupils are taking a special course in cotton picking.

Capt. W. N. Carter of Orlando was found dead by his bed last Saturday morning. He was eighty years of age.

Lake City is enjoying a little building boom. Quite a number of attractive cottages and residences are being put up.

Four crates of limes and twenty-bushels of guavas were shipped from the D. & H. grove in Wulffert last week.

J. W. Clyatt killed a big rattlesnake with eight rattles and a button last week on his place about a mile south of Lake City.

The truck growers at Dania are getting their land ready for tomatoes, beans, potatoes and peppers. A large acreage will be planted this season.

The Suwannee River and White Springs railroad will soon be completed. Work is being rapidly pushed forward in grading the road properly.

Henry McLaughlin, a railroad man from Pensacola who went to Mobile last week to have an operation performed for appendicitis, is reported to be doing nicely.

A washout on the bay front near Pensacola last week delayed all the boats going to DeFuniak several hours, as they had no freight from the West that day.

The daily train service between Kissimmee and St. Cloud has been inaugurated. This is a great improvement over what these people have known in the past.

The machinery for Ferdinand's factory for dicing and evaporating fruit products has arrived and is being put up. This is an entirely new industry for the South.

Little Ruth Brisson died in the hospital at Orlando last week from the effects of having swallowed a safety pin. The body was laid to rest at Sanford, the home of her parents.

C. N. Hull & Co. of Sarasota will ship 1,500 head of cattle. Their cattle on the range are now beef fat and doing well. A large part of their business has already been contracted for.

The Day of Atonement, or Yom Kippur, the most important of all feasts on the Jewish calendar, was observed in Pensacola last Friday and Saturday with most impressive services.

The Mississippi-Atlantic Inland Waterway Association will meet in Jacksonville on November 15th and 16th. Some noted speakers from all over the country are to be present and will give silver addresses.

Last week the "Tarpon," a boat at Alachicola, took 650 bales of cotton and 150 barrels of spirits of turpentine to Mobile from that point. It now 600 bales of cotton and 500 barrels of naval stores await the camer.

Col. W. E. Gullette, owner of the Jacksonville baseball franchise and manager of the Hirsch Lumber Co., who has been very ill at the DeSoto sanitarium in Jacksonville, is improving. Grave fears were felt for a while that Col. Gullette would not recover.

About two hundred prospective settlers arrived in St. Cloud last week from different parts of the country, mostly from Washington, D. C., and Cincinnati. They have expressed themselves as well pleased with the town and most of them will locate there.

BEARD QUILTS POLITICS.

Spectacular Figure Will Be Seen No More in Legislative Halls.
(Ocala Banner.)

State Senator John S. Beard of Escambia county, one of the most spectacular figures in Florida's political arena in recent years, has quit the game. In The Pensacola Journal he announces that he will never again take an active interest in politics other than the interest which he feels that every citizen should take.

As a candidate for Congress, a delegate to the national convention, a candidate for the United States Senate, and an active participant in every political campaign for past years in this State, Mr. Beard has occupied an important and prominent place in the politics of Florida.

He has attracted national attention by his efforts to pass a disfranchisement measure through the Legislature in violation of the fifteenth amendment in order to have Florida carry up a test case before the supreme court on this amendment. This pet measure was forever laid to rest by the last Legislature, after a magnificent fight on his part. During the last session he attracted State-wide attention by his denunciation of Governor Gilchrist, because of the stand taken by the State's chief executive relative to the Wallis-Beard Indian war claims.

In his notice of retirement from active politics he says:

"I have absolutely and permanently retired from politics. While I shall always take the interest in public questions that I think all good citizens should take, I will not again be a candidate for office, nor will I again take an active part in politics.

"I shall, from now on, energetically devote my time and attention exclusively to my profession, and am prepared to practice in all of the State and Federal courts.

ALACHUA HAS SOME BAD NEGROES ALSO

ONE OF THE NUMBER BROUGHT HERE THURSDAY.

Constable Spencer Had Trouble With the Man in Bringing Him Here.

Alachua has some bad negroes also, judging from the "big bully" that was brought down Thursday by Constable Spencer, who had no end of trouble with the man.

Rogers Brown, the negro in question, was very abusing to the officer, and really wanted to scrap with him a number of times—his language at times being almost unbearable, but owing to having the man under his charge he passed his remarks unnoticed.

When the negro arrived here and tried some of his remarks with the officers he was soon shown that such "slack" did not go, and was given to understand that he was to obey, and not the officers.

Justice Sealey sent the man up on a charge of assault, and he will now be required to serve the next few months in the camps near Holder for Rawls & Co. for his conduct; besides, he is entitled to just a few months extra for the manner in which he acted after being turned over to the constable to be brought here.
