#### Grand Jury Presentments.

We, the Grand Jurors enquiring in and for the body of the county of Wakulla Fall term of Circuit Court, A. D. 1897, do make the following general presentments.

1st. We find that the County Judge, Sheriff, and Clerk of Court have complied with Sec. 3rd, Chap. 4141, laws of 1893 and we file their statement here with.

2nd. Under Sec. 17, Chap. 4338, laws of 1895, we report as follows; we find that the public roads and bridges in the county are in good condition.

3rd. We respectfully call attention to the fact that a more comfortable chair should be furnished the presiding Judge, and hope by next term of court they will furnish a more suitable one for the bench.

4th. While we have had to act on but few cases called to our attention by the proper authoritities, yet the number is larger than heretofore, and we hope that a check may be put to the commission of crime in the county, by the exercise of good sense and standing by the law loving people of the county.

5th. We tender our thanks to his Honor, Judge John W. Malone, for his able, comprehensive and explicit charge relating to our duties and congratulate, the people upon the rapidity and legal correctness with which the business of the court is disposed of.

### A WARNING

Chapter 4026, Section 1. That from and after the passage of this act, it shall be unlawful for any storekeeper. saloon keeper, merchant, or any other person or persons, their agents, clerks, managers or assigns, to sell to, buy for, give to, or in any other manner dispose of, to any person or persons under the age of eighteen years, eighrettes, smokettes, or eigarette paper, when prepared for the purpose of making cigarettes of any kind or description whatsoever; any person or persens who shall violate the provisions of this act, shall be deemed guilty of misdemeanor, and upon convighereof, shall be punished by imprisco nent in the county fail not to exceed 30 days, or by fine not to exceed one hundred dollars.

To Crawfordville storekeepers, merchants, or any other person or persons, their agents clerks managers or assigns, that from and after the publication of this notice in this paper, any person or persons, guilty of violating Sec. 1, chapter 4024, Appendix, Revised Statutes of Florida, shall be prosecuted to the fullest extent of the law.
