## FOR A TUBERCU- LOSIS SUNDAY.

Announcement of a national tuberculosis Sunday to be held on April 24th in 215,000 churches of the United States has been made by the National Association for the Study and Prevention of Tuberculosis.

Following campaigns against consumption that have been carried on in the churches of hundreds of cities, and sermons on tuberculosis that have been preached before thousands of congregations during the past year, a movement has been started to establish a permanent tuberculosis Sunday, on which it is hoped that every one of the 33,000,000 churchgoers in the United States will hear the gospel of health. It is planned to enlist the active co-operation of anti-tuberculosis organizations, labor unions, fraternal organizations, and other bodies together with the churches in the movement. The aid of leading churchmen in many of the principal denominations has already been offered. All of the large interdenominational bodies, such as the Young Men's Christian Association, the Young Women's Christian Association, the King's Daughters and Sons, and the various young people's societies are also in sympathy with the anti-tuberculosis campaign.

It is planned that on April 24th tuberculosis sermons shall be preached in all the churches of the country. Literature will be distributed to members of the congregation, and in every way an effort will be made to teach that tuberculosis is a dangerous disease and that it can be prevented and cured. Clergymen who desire to obtain information in regard to tuberculosis will be able to secure literature from state and local anti-tuberculosis associations and boards of health, as well as from the National Association.

The Florida orange grower who had the good luck to escape with his fruit untouched by the Christmas time freeze is now strictly in it. The New York market shows round oranges selling at \$1.50 to \$2.00, and grapefruit from \$3.50 to \$5.50.

Judge T. M. Paleston, county judge of Jefferson county for the past more than 20 years, is dead of heart trouble. He was one of the best loved men of Monticello, and was prominent throughout the state, especially in Masonic circles, of which order he was a Past Grand Master of Florida.

Editor L. W. Zim of the St. Augustine Meteor has been at least temporarily lost to the journalistic profession in Florida. During his campaign for congress he has turned his paper over to other parties, and will devote himself exclusively to his campaign. This action says Mr. Zim, "is taken in justice to the friends who inspired my candidacy."

Dr. E. S. Crill of Palatka, has announced that he will not be a candidate for Putnam county. This will be widely regretted. For many years the gentleman has been a potent factor in legislation. No one will be missed more. Dr. Crill and Frank Adams were two of the ablest men who ever served in the Florida legislature, and now both have had enough.—DeSoto County News.

Over in Volusia county there is something of a scramble among the politicians over who will succeed to the office of state senator in place of Frank Sams, while for the office of representatives, of which there will be two, nothing much is being said. If the News were permitted a suggestion along this line, it would be that the good people of Volusia pick up Editor Ben Prevatt and send him to the House of Representatives. He has done a heap for Volusia, and there is no better legislative timber in the entire county. This man will have to be "picked up" and placed in office, for he is not an office seeker.

Out of a total amount of the Rivers and Harbors Bill fund of \$1,101,000 Jacksonville will get \$337,400 for improvements in the harbor and the citizens are up in the air because more money was not given to Jacksonville. This is very commendable on their part, and we wish to go on record by saying that while Sanford people are glad to get the deep water promised we want more and while Senator Taliaferro is spending so much of his time for Jacksonville, it would be most prudent for him to buzz around Sanford some. Maybe Claude L'Engle and Napoleon Broward can get deeper water for Sanford than Taliaferro. We want the man that has the longest shovel.—Sanford Herald.

Notice from the Bureau of Soils of the U. S. Department of Agriculture, is to the effect that "a soil survey of the trucking soils in the immediate vicinity of Jacksonville, Fla., has been recently undertaken by the Bureau, and Mr. Grove B. Jones has charge of the work assisted by Mr. J. E. Ferguson. During the present winter it will be possible to complete a soil survey of about 400 square miles in extent in the vicinity named. In this way the character and extent of the different soils and their adaptability for the production of a wide range of truck crops will be ascertained. The chamber of commerce of Jacksonville, Fla., requested this work some time ago and it has just been found possible to detail a soil survey party to undertake an examination of the soils in this vicinity. It is anticipated that the field work will be completed early in April and that the report upon the results will be published and ready for distribution during the summer of 1910."

Palatka democrats have every reason to remember the "business senator" for his matchless inactivity at Washington in behalf of deeper water on the St. Johns river south of Jacksonville. The government is to spend the munificent sum of \$32,400 on the river between Jacksonville and Lake Harney, and \$37,400 for improvement of the harbor at Jacksonville. The people of that city are kicking because they didn't get more. Might be well to do a little more kicking up here.

## Florida Christian Endeavor News.
