**JUDGE LIDDON.**

It is doubtful that Mr. Justice Liddon, who has been suggested by an enthusiastic newspaper friend for the United States senate, will take kindly to the proposition. He now holds the very highest office within the bestowal of the people, enjoying the honors of which his life's ambition is realized, and forsaking which to engage in the turmoil of active politics would jar harshly on a nature attuned to less discordant notes than the incessant din of factional partisanship.

If the above paragraph taken from the columns of the Pensacola News is intended to forestall the likelihood of Judge Liddon's promotion to the high and honorable position of United States Senator it will be resented by the friends of that gentleman, but if the News simply meant to pay him a deserved compliment, as it certainly did when it said that he was possessed of a nature "attuned to less discordant notes than the incessant din of factional partisanship," then the friends of Judge Liddon will enjoy and appreciate its observations as coming from a most estimable source.

The democrats of Florida, as a

whole, long since tired of the unseemly combat that has been in progress between Wilkinson Call on one hand and a few politicians on the other over the seat in the senate now occupied by Mr. Call, and there is a strong sentiment among the rank and file of the party in favor of raising this exalted position above the incessant clamor and strife of factionalism. It is self-evident that to reach this most happy termination to a long and unpleasant strife the party must turn from Mr. Call and his assailants to a man whose very nature suggests higher and nobler things than a participation in the incessant din of factional partisanship. It will not be surprising, therefore, if the sentiment in favor of the passing of the senatorial turmoil, which has a foundation in the heart of every democrat who is desirous of party unity, centralizes upon Judge Liddon, who, as the TELEGRAPH has before remarked, enjoys the distinction of being the only man in public life in Florida who has a united party at his back.

We do not believe with the News that Judge Liddon's life's ambition is fully realized in the enjoyment of the honors of the sacred trust that has already been committed to his keeping. Like any other man who has placed the best qualities of his head and heart in the execution of his duty to his people and his state he would undoubtedly be rejoiced by an acknowledgment of his services through the bestowal of still higher honors.

**NEGRO EDUCATION.**

State Superintendent Sheats is credited with the following statement: "I now serve public notice upon their unwise friends, and the negroes as well, that I pledge myself to lead a movement in this state with a design of so amending the state constitution as to relieve the whites from all connection with negro education, and to cease all appropriations to their schools of every grade, only as it is paid by negro tax payers.

If Mr. Sheats really contemplates any such action he may as well prepare his nerves for the shock that naturally attends defeat. Just such a movement was led by one of the representatives of Mr. Sheats' home county in the legislative session of 1893. The design of the legislator from Alachua failed utterly of accomplishment, and so will Mr. Sheats fail.

The point involved in such a movement has long been settled in the minds of the people of Florida. They long ago recognized the fact that the elevation of the negro to a higher plane of citizenship is merely a matter of good policy, and they accept the expenditure of the money required for the education of the blacks as one of the legitimate expenses of our state government.

It is too early yet to predict with any degree of certainty who will be the next United States senator from Florida. There are a number of democrats in the state who are capable of representing the people in the upper house of congress. These men have many friends who will, doubtless, later on take occasion to urge the claims of their favorites. Any democrat who has an ambition to reach the senate should be given a perfectly fair showing. He should be judged as nearly as possible for what he is worth, or in other words his fitness for the position. We presume there is not a democrat in the state who questions the competency of Judge Liddon. It is apparent, however, that the News hopes he will not be a candidate. It is not a difficult matter to see why the News opposes Judge Liddon. The reason assigned by the News why Judge Liddon should not be a candidate is, as a matter of fact, a strong argument in his favor. If the Judge should succeed to the senate it is not probable, from his past record, that he would "engage in the turmoil of active politics, which would jar harshly on a nature attuned to less discordant notes than the incessant din of factional partisanship." Judge Liddon has not been in any manner mixed up with anything that would demand of him an active participation in any squabbles or wranglings inside the democratic party. We do not know what Judge Liddon's wishes may be regarding the senatorship, but we feel convinced that if he has an ambition to reach the senate he will not be caught napping by the News. He is too old a bird to be caught with chaff. The talk of the News might work in some cases, but with a man like Judge Liddon it will cut but a small figure.
