We, the undersigned members of the City Council of the city of Tallahassee, Fla., do earnestly request that you do not pay your December bill for gas to the Capital City Light and Fuel Company until the Council advises you to do so. We would like for you not to pay any more bills at all for the present, as we consider it an outrage and injustice to you for the gas company to try to make you put up with such poor gas. There are two ways to make the Capital City Light and Fuel Company furnish good gas; the first is for the gas users to refuse to pay the bills of the gas company, and the second is for the City Council to tell them that if they do not furnish good gas, they, the City Council, will revoke their charter. This the City Council has done and we expect to do what we said we will do. It is true we would like to have gas but we can get along without it, as we have practically been doing off and on for some time. Now if the gas company wants to keep on doing business in Tallahassee they must give the gas users of Tallahassee good gas, and we ask you to help the City Council in its fight for good gas.

OFFICIAL CALL.

City Democratic Primary Election Called to be Held Tuesday, January 28th, 1908.

THE DEMOCRATIC EXECUTIVE COMMITTEE of the City of Tallahassee, Fla., hereby call and provide for the holding of a Democratic Primary Election to be held in the City of Tallahassee, Fla., in the office of the Sheriff in the Court-house of Leon County, on Tuesday, the 28th day of January, A. D. 1908, from 8 o'clock a. m. until sundown, for the nomination of all Democratic candidates for offices to be voted for by the Democratic electors at the Municipal Election to be held on the 18th day of February, A. D. 1908, in said city, and also for members of the City Democratic Executive Committee. Provided, that a second primary, where necessary, shall be held on Tuesday, the 28th day of February, A. D. 1908, to choose between the highest candidates, where nominations shall not have been made by a majority vote in the first primary election, and at such second primary election only such electors as were qualified to vote at the first primary election shall be permitted to vote.

The Democratic City Executive Committee calling said primary election hereby declares the terms and conditions on which legal electors offering to become candidates or to vote at such elections shall be regarded and taken as proper members of the Democratic party and therefore entitled to participate and be candidates before and vote at such elections, as follows:

Those, and only those persons shall be permitted to become candidates before or to vote at or participate in the management of any primary election held by the Democratic party in said city, who are white Democratic electors, who declare their adherence to the principles and organization of the Democratic party, national, State, county and city, who are by the laws of the State of Florida and the ordinances of the City of Tallahassee lawful electors of said city, who have paid their poll taxes legally due not less than ten days before such primary election is held, and who shall, when challenged by any elector, pledge in writing upon oath before an inspector to abide by and support the result of such primary and vote for the nominee thereof.

Provided, That each person designated by the City Democratic Executive Committee shall open registration books and keep the same open for the registration of voters in said city on the 8th day of January, 1908, to January 20th, 1908, inclusive, and shall register in said books any white Democratic person applying who is entitled under the State and City Election Laws to be registered, and persons so registered shall for the purpose of said primary election be deemed to be lawfully registered.

Each elector in said city qualified to vote in said primary election shall have the right to vote for one candidate for Mayor, five candidates for City Council for the full term, one candidate for City Council for unexpired term of one year, one candidate for City Clerk, one candidate for City Tax Assessor, one candidate for City Tax collector, and five candidates for the City Democratic Executive Committee.

Each person desiring to have his name printed on the Primary Election Ballots as a candidate for any of the above mentioned offices, including members of the City Democratic Executive Committee, shall leave with the Chairman of this committee on or before the 15th day of January, 1908, his notice of candidacy and application to have his name so printed upon a blank to be furnished by the said Chairman, and accompanied by an amount of money equal to four per cent of the annual compensation of the office for which he is a candidate, and no name of any such candidate shall be printed upon, or counted, or returned if printed upon any such ballot, unless this provision shall have been complied with. Said Chairman shall immediately after the 15th day of January, A. D. 1908, furnish to each newspaper, published in said city, for publication, a list of all the names which have been filed as candidates for such offices.

The voting in said primary election shall be by ballot prepared and used in accordance with the provisions of the State election law, and shall be printed and distributed under the direction of the said City Committee, and on said ballots shall be printed, first, the names of all candidates for Mayor; second, the names of all candidates for the City Council; third, the names of all candidates for Clerk; fourth, the names of all candidates for Tax Assessor; fifth, the names of all candidates for Tax Collector; and sixth, the names of all candidates for City Democratic Executive Committee, the names of each group of candidates to be printed in alphabetical order on each ballot.

The City Democratic Executive Committee shall, at noon on the 6th day after such primary, or sooner, if all the returns are in, meet at the City Hall and publicly canvass the returns and declare what candidates have been nominated by a majority vote for each office, including members of the City Democratic Executive Committee, and in what cases a second primary will have to be held.

Each candidate for office being voted for shall have the right to place one watcher and challenger at the polls, which said watcher and challenger shall be entitled to be present during the entire time the polls are open to challenge voters, also to witness the counting of the vote and certifying of the results after the polls are closed.

The ballots, poll lists, returns and other records of the election shall be preserved by the City Executive Committee after the primary has been held.
