## Pulliam Heads Reform School

Former Sheriff of Coconino County Named as Superintendent of Fort Grant Institution by the Board of Control.

After six months of deliberation, the state board of control yesterday appointed Thomas E. Pulliam, of Flagstaff, former sheriff of Coconino county to the position of superintendent of the state industrial school at Ft. Grant. He will take charge of the institution January 1.

Pulliam, who came to Arizona twenty-five years ago, has for a number of years taken an active part in the political life of Coconino county where he has made his home. In 1896 he was elected to the office of county recorder by a large majority, and at the close of his second term elected a member of the board of supervisors. For the last three years he has held the office of sheriff of Coconino county, but refused to be a candidate for re-election this year. He was chosen after the board had reviewed the applications of between forty and fifty candidates for the position.

The appointment of a new head for the industrial school has been before the board of control ever since last spring, when W. M. Whipple tendered his resignation as superintendent after a brief but stormy administration. Since his retirement on June 30 the affairs of the institution have been in charge of Prof. Gunz, the bandmaster at the school.—Phoenix Republican.

## Another Setback To Fixed Prices

Court Rules Contract Requiring Sale at Specified Figure Not Only Unenforceable, but Invalid as to Collection of Money.

Regulation of the resale price of merchandise either by contract or by the exercise of patent rights again has struck a snag.

The case in question is that of the McCall Pattern company against Patrick O'Neill, an Ohio merchant, in which the pattern company sued on a contract stipulating that the patterns should be sold at the regular catalogue price "and none other."

The pattern company made its contract the chief feature of its complaint. O'Neill based his defense on the ground that the contract was in violation of the Sherman anti-trust law and thus invalid. The plaintiff set up the claim that because the articles were patented, it had a right to set the price, but the court disposed of that contention adversely to the McCall company, basing its conclusion upon a decision of the United States Supreme Court, which held that a patentee could not control the price at which a patented article should be sold, after there had been a full and complete transfer of the patented article including title, to a purchaser, and the attempt to reserve the right to fix the price at which the article shall be resold is further under the statute.

The court also held that this being a contract which was unlawfully against public policy and therefore void the McCall company could not even recover \$100 standing credit or \$144.87 for goods sold and delivered. Thus a merchant who buys goods from a manufacturer under a resale contract cannot be compelled to pay his bill for merchandise.—Los Angeles Apparel Gazette.

## Hunt Will Delay 80 Per Cent Law For U. S. Action

Washington, Dec. 7.—Officials think the validity of the Arizona law requiring that eighty per cent of the employes be American citizens in all business homes employing five or more persons, which has been protested by the British and Italian ambassadors, hinges upon the legal interpretation of the navigation and commerce treaty with Italy. It is generally accepted that a treaty is superior to a state law.

The British treaty does not define the rights of foreign citizens as specifically as does the Italian. A telegram has been received from Governor Hunt expressing a willingness to delay the proclamation of the law, although he is averse to much delay.—Arizona Record.

### IN THE TOILS

#### Navajo County Relieved from Prosecution of Bogus Check Artist

Some few weeks ago Arthur Jarvis accepted a check from one who signed his name as J. A. Otten, in the sum of \$20, covering payment for gasoline and garage services. The check proved to be worthless, which fact Mr. Jarvis reported to the authorities here. The Sheriff's office immediately took the matter up and succeeded in capturing the party in Flagstaff. He was brought here where he was bound over to the Superior Court on charge of issuing bogus checks. Information was filed against him by the County Attorney and when the defendant was called up yesterday to be arraigned on the information against him the County Attorney moved for the dismissal of the charges against him for the reason that an officer of the Sheriff's office of New York City appeared here with a certified copy of an indictment that had been found against one J. A. Petinger for the more serious crime of Grand Larceny. The defendant admitted that his proper name was Petinger and the Court ordered that the prisoner be turned over to the New York authorities for prosecution of the indictment held against him in that State. Mr. McMachon, Deputy Sheriff of the County of New York N. Y., left with the prisoner for the East today.

## Forest Exhibits For California

Part of the government's exhibit for the Panama California exposition at San Diego leaves Washington this week. This portion has to do with the national forests of New Mexico, and will be shown in the New Mexico building, the exhibit having been prepared in cooperation with the state board of exposition commissioners of that state. The material also shows specimens of the principal timber trees of New Mexico, their uses, etc.

Other exposition material is to leave soon for San Francisco, where it will form a part of the Panama Pacific exposition. Part of this is being prepared through cooperation between the forest service and the United States civil service commission. The commission passes on the qualifications of all candidates for positions in the forest service, testing fitness of those who wish to become forest officers through outdoor examinations in riding, surveying, timber estimating, and similar matters as well as by more conventional methods; its exhibit will illustrate the duties of these officers.

Cooperation also exists, in the preparation of exhibit material, between the forest service and the bureau of education. This shows how forest subjects are used in the public schools, in connection with nature study, commercial geography, agriculture, and the like. One of the exhibits is a display made by the normal school pupils of the District of Columbia, in which a number of these who are studying for teachers' positions entered a prize contest on tree study. Each of the contestants prepared a separate exhibit showing the life history and products of individual trees, such as white pine, hickory, or sugar maple.

#### Death of Jacob Foster

Jake Foster, an oldtime resident of Navajo County, died at the Brunswick Hotel at this place last Tuesday afternoon. The deceased had been suffering from ill health for a long time. The immediate cause of death is said to have been dropsy. So far as known he had no relatives in this part of the country except a half-brother who lives down in the Gila Valley. His mother died several years ago at St. Joseph and Jake's remains were taken to that place for burial. While Jake had not been very successful in gathering together very much of this world's goods, he was well liked by all who knew him and he will be greatly missed by a number of his old cronies.
