THE Phenix Gazette, which has never missed an opportunity to flatter Judge Barnes and Marshal Meade, has at last discovered that his Judgeship is not just the person which he has been cracked up to be and goes for him in the following approved fashion:

NEW YORK, Jan. 26.—All horse cars leaving the Atlantic Avenue railroad camp, Brooklyn, seven in number, are tied up this morning by the employes. The men demand \$2 per day.

Considering Utah's Claims.

WASHINGTON, Jan. 26.—The House committee on Territories met to consider the bill for the admission of Utah, but an adjournment was taken until Wednesday without action.

A New Gold Field.

SAN BERNARDINO, CAL., Jan. 26.—Gold has been discovered in City Creek, ten miles from here, that assays from \$30 to \$10,000. One eighth of one claim was sold for \$5,000. Great excitement exists and crowds are going to the new mines.

Missionaries Murdered.

ZANZIBAR, Jan. 26.—An English missionary, named Brooks, and sixteen of his followers were murdered on Saturday near Saadani, by coast tribes and natives of Zanzibar. The question as to the measures England will take to punish the murderers is being eagerly discussed.

House.

WASHINGTON, Jan. 26.—The army appropriation bill was reported and placed on the calendar, also a bill to establish a military and naval museum in the city of Washington. The House then went into committee of the whole on the sundry civil appropriation bill.

O'Brien Sentenced.

DUBLIN, Jan. 26.—When the trial of Wm. O'Brien was resumed today O'Brien was absent but the trial proceeded and he was convicted and sentenced to four months imprisonment without hard labor. The police have discovered no clue to O'Brien's whereabouts.

Morrow on Samoa.

WASHINGTON, Jan. 26.—Representative Morrow, of California, chairman of the sub-committee of the House committee on foreign relations, intends to call the sub-committee together and get to work at the earliest opportunity. He says his views of the Samoan affairs are positive and have been made known through a resolution introduced by him in the House last session. The condition of affairs existing at the time the representatives of the United States, Germany and England met he says must be restored, and this would necessitate the replacement of King Malietoa in the position from which he was so unjustly removed by German agents and sent to the Marshall Islands. This step Morrow insisted must be preliminary to any further investigation on the subject.

Death of a Prominent Citizen.

PHILADELPHIA, Jan. 26.—Samuel M. Letton, ex-president of the Philadelphia, Washington and Baltimore railroad, died last night aged 79. To Letton the credit is given for enabling President Lincoln to pass through Baltimore on his way to his inauguration unrecognized.

Senate.

WASHINGTON, Jan. 26.—The committee on Territories today took up the House bill passed the other day for the admission of North and South Dakota, Montana, Washington Territory and New Mexico into the Union. After a session of two hours one of the committee said: "We have spent the entire session in considering this bill, and it is noticeable for contradictory provisions and inadequacy to get any Territory or part of Territory into the Union as a State. If we are to pass the measure it must be corrected materially. It has been referred to a committee with instructions to see if its inconsistencies can be so reconciled that we can recommend its passage.

When the appropriation committee reported the consular and diplomatic appropriation bill, Allison moved that the Senate insist on its amendment to the tariff bill, and asked a conference with the House on the bill and amendment agreed to.

Short \$300,000.

INDIANAPOLIS, Jan. 26.—The announcement was made last night by Col. Jacob L. Green, of Hartford, president of the Connecticut Mutual Life Insurance Company, that Joseph A. Moore, financial correspondent of the company at Indianapolis, after fifteen years of service is a defaulter. The extreme amount involved is believed to be more than \$500,000. He has restored to the company property which may reduce the actual loss to \$400,000. Moore is a leading citizen of Indianapolis, about 45 years of age. He has not yet been arrested and no criminal proceedings have been begun against him. He is remaining in seclusion in the city and positively refuses to see anybody. He was also agent for other insurance companies and is supposed to be short in his accounts with them.
