## Under Which Flag?

PEOPLES PARTY PLATFORM

For President, W. J. BRYAN, of Nebraska, For Vice-President, T. WATSON, of Georgia.

We demand:—

I. The free and unrestricted coinage of gold and silver at the present ratio of 16 to 1 without regard to the wishes of any other nation or combination whatever.

II. The increase of the current money to an amount sufficient to meet the wants of our growing population and business, such money to consist of silver and gold coin and U. S. Treasury notes, equally a legal tender for all demands public and private.

III. The abolition of all national banks and the establishment of Postal Saving Banks, managed and controlled by the U. S. Treasury.

IV. The establishment of a system of direct legislation by the people, giving to the people the power, 1st. To veto all laws passed by any legislative body; 2d. To propose, amend, and repeal laws by any number greater than five percent of the electors and compel their submission to the whole body of the electors.

V. That all means of transporting persons property and intelligence be gradually taken by the Nation and conducted and controlled by a bipartisan commission under strict civil service rules.

VI. That all public salaries and compensations shall be made to correspond to the price of labor and labor's product.

TOMBSTONE, September 20, 1896.
