THE ROBBERS AGAIN.

The Marshal's Posse in Front and Rear.

Authentic news received today from the fight of the marshal's posse with the robbers, after the skirmish, fled from the posse going direct toward their old haunts in the Chiricahua mountains. The fight was a complete surprise to the robbers, the latter nearly running onto the posse in front who lay in waiting while the band was being pursued from the rear, running the robbers into the trap. The fight did not last long but was a most fierce battle while it lasted. Hayes was killed and his body recovered. Jess Williams was wounded and was heard to exclaim to Black Jack that he was shot and was seen to reel in his saddle. Instantly Black Jack rode along side and held his brother robber on the saddle while they rode off at break neck speed. The last seen of the robbers the two was riding side by side, Black Jack holding his wounded companion on his horse, the posse following in hot pursuit, while the body of Hayes was removed to Sagar. It is reasonably expected by this time the capture or death of both robbers has doubtless been made, as they will be much handicapped in their escape because of the wounded Williams who appeared to be helpless.

A MISUNDERSTANDING

The Result of Which is Probably Fatal.

Andy Garrett, well known in Tombstone, arrived in town yesterday and told the story of having killed a cowboy named Chas. Cook just below the line near the custom house. The shooting was the outcome of a misunderstanding or quarrel, Garrett claiming to have shot Cook in self-defense. Cook was taken to La Morita where it is believed he died from the effects of the wound. As the affair occurred in Mexico the trial of the case cannot proceed unless extradition papers from Mexico are issued. Garrett came here with the evident purpose of giving himself up could a trial be had on this side. He could not be seen today, having gone to Pearce, and no further particulars are obtained. It is stated that a gentleman named Brigham, who lives in the Salt River valley, and who is a nephew of Mark Hanna, is likely to be the next governor of Arizona.—Courier. A CASE OF LEPROSY.

A Case of the Loathsome Disease Exists in New Mexico.

The territorial board of health has recently received a report of a case of leprosy existing in the territory says the Las Vegas Optic. The victim is a Mexican man living a hundred miles or so from any railroad and near no large town. The case has been inspected by a clever physician who has seen the disease in other countries and issued his diagnosis. Under the present status there seems to be no way in which the case can be properly isolated. That the case appears to be a genuine leprosy would readily be understood by physicians when it is stated that the man's fingers and toes have dropped off, that swellings characteristic of the disease have occurred and that various spots of his skin are anaesthetic, that is, without feeling. It is not known whether leprosy has been seen before in New Mexico but it exists in old Mexico, New Orleans, San Francisco and other parts of the United States. But it is the aim of modern sanitary science to prevent the establishment of this dreaded disease in America with its horrors, as they prevailed in the orient in ancient times. Editor Bryson of the Louisiana, Mo., Press gives the following gentle hint to delinquents: "Perhaps we ought not to inject private matters into public notice, but we feel impelled in a burst of confidence to state that the treasury reserve in this shop was never so low as at the present moment. JUAREZ A MONTE CARLO.

Sporting Headquarters May Be Transferred to the Line.

Dan A. Stuart is expected in El Paso next week. It is generally known that Mr. Stuart is working to secure a concession from the Mexican government for sports in Juarez, says the El Paso Times. If Mr. Stuart succeeds, and it is most likely that he will, sporting headquarters in the United States will be transferred from New York to El Paso. The concession will call for horse racing pugilistic assaults, and gaming of all kinds. The fact that New York, the empire state of the United States, has passed a law permitting boxing contests, will no doubt influence the Mexican government to look with kindness on Mr. Stuart's scheme. "The people of El Paso," said Mr. Stuart to a Times reporter recently, "have no idea what it will mean for El Paso to transform Juarez into a Monte Carlo. The money for \$300,000 worth of buildings and race tracks has already been subscribed, and if I am successful in my negotiations, double that amount of money will be spent in El Paso by our company during the next six months. We are going to have this Monte Carlo somewhere in the United States, and I prefer this point because El Paso has railroads reaching out in every direction, and in the course of time they could be induced to help El Paso in order to help themselves." DISTRICT COURT

Cases Heard Before That Tribunal Today.

Court opened this a. m.; after making some orders in reference to legal points in various cases and ordering the clerk to prepare abstracts of some papers, adjourned until next regular term, making nearly a clean sweep of all cases on the calendar, judgments in some of which will be rendered during vacation. Among the five cattle buyers from the coast now at Phenix is J. E. Dunn, who is looking at some herds. All of a sudden the demand has begun to increase rapidly and there are not so many fat beef steers in the valley as usual. Probably 14,000 head of beef cattle altogether is now on pasture. The recent storm at Chicago was the cause of a curious phenomenon in Chicago harbor. In the Illinois central slips there were thousand of dead fish which were evidently forced into the harbor by the heavy blow. They were smaller than the ordinary minnow, and no one seemed to know what the species was. They covered the entire surface of the two slips, which are some distance from the mouth of the harbor, and were so thick that bushes of them were scooped up in the deep nets.
