E. P. & S. W. TO PUT BACK TRAIN BETWEEN BISBEE AND DOUGLAS

Other Changes in Time-Table; Only Slight Change On Local Branch

BISBEE, Feb. 26.—One of the very best signs yet of the general improvement that has come about and of the confidence that is held in its permanency of character, is given by the E. P. & S. W. in announcement that it will resume the train service between this city and Douglas which was suspended in August. The train restored operates directly between Douglas and Bisbee and will begin its run on March 1. It will leave this city at 2:15 p. m., arriving at Douglas at 3:30. Returning this train will leave Douglas at 4 p. m., arriving here at 5:15 p. m. It will bring El Paso connection. Formerly this train left Bisbee in the mornings and returned in the evening. The afternoon schedule is considered as certain of proving more popular and a larger convenience to the public.

Aside from the return of the direct train service on March 1 between the city and Douglas, there will be slight change in the schedule of the Golden State Limited, which is to make faster time between El Paso and Tucson. The train westbound will leave El Paso later and arrive at Osborn a little later. The connection from this city will leave beginning on the first at 9:05 p. m., instead of at 8:25 as at present, returning will arrive in this city at 10:15. Only Pullman cars and first class tickets will be carried on the train beginning with the first. The east bound Limited will continue on its present time, leaving this city at 6:15 a. m.

A slight change has been effected in the local timetable, the Benson train leaving at 11:40 instead of 11:30 as previously.

COCHISE COUNTY STOCK-GROWERS WILL MEET AT WILLCOX

The annual gathering of the Cochise County Stockgrowers' association will be held March 15 in Willcox. At it the officers who will serve through the next year will be chosen and other details of association business attended to. The semi annual meeting of the association was held in Douglas in January, having been postponed past its regular date in order that the delegates might attend the convention of the state association which met in that city concurrently.

J. T. Hood, of Douglas, who is secretary, has mailed notices of the Willcox meeting to all members. There are now about 175 members in the county organization, which is quite active in affairs affecting the stock business. State Senator Riggs, of Dos Cabezas, is its president.

The invitation includes the wives and lady friends of the members who are urged to attend. The people of Willcox will prepare suitable entertainments for the fair sex as well as their husbands.

A large local delegation is expected to attend.

NEWS OF IMPORTANT STRIKE IN COCHISE STRONGHOLD

Claim Veritable Bonanza Has Been Encountered In Famous Canyon

News of an important gold and silver strike in the famous Cochise Stronghold, has been brought to the city by James Barrett, the well known Tombstone pioneer mining man.

The reports are that the properties known as the Grant claims, owned by Charles Grant and his two sons, of Pearce, and on which they have been working for the past several years, a large body of ore has been encountered running high in values of gold, silver and lead, with a slight trace of copper.

It is stated that no limit to the discovery has been placed, and the width of the ledge has not yet been ascertained by the owners, and may be classed as a veritable bonanza of the early day variety.

The property lies in the famous Cochise Stronghold, not far distant from the Sorin ranch, in that section, and directly adjoining the Gordon zinc properties. Claims also adjoining are owned by the Airl brothers, of this city.

This section of the Dragoons has long been known to contain high values in gold and silver bearing ore, and all that has been lacking was money for development. Of late, zinc in large quantities has been discovered, and Jonathan Gordon, assayer and chemist of Tombstone, is said to have acquired some valuable holdings in that district, and he is at present prosecuting development work on the properties.

No further news of the strike has been available.

SPEAKER BROOKS INTRODUCES BILL WHICH WOULD REVOLUTIONIZE LEGISLATIVE PROCEDURE

Would Have Sessions Biennially and Last Until All the "Completion of All Business Requiring Consideration;" Gov. Could Call Extra Sessions

BILL REQUIRING STATEMENT OF PARTY AFFILIATIONS PASSED

PHOENIX, Feb. 26.—In spite of the fact that the second legislature is rushing madly towards the day of its dissolution, there is little letup in the number of new bills which daily find their way over the bar. Not many of these have a chance of becoming laws, but they will make fine talking points when the statesmen get home.

The effort to make Arizona a military monarchy was shifted today from Tempe to Prescott when the clause in the house educational bill making the Tempe Normal a training school for soldiers, was withdrawn and Senator Goldwater in the senate a measure looking to the acquiring by the state of the old Whipple barracks at Prescott to be used in the establishment of a state military school.

In the house the question was chiefly over the Tempe Normal school bill. The bill somewhat extends the curriculum, provides for the granting of degrees and fixes the name of the school as the Normal College of Arizona.

It was finally recommended by the committee of the whole that the bill "do pass."

Quashed by the overhanging horizon of the impending end of all things legislative, Speaker Brooks fathers a bill materially changing the manner of conducting the legislature.

The proposed act provides that the sessions shall begin biennially on the second Monday in February, when a month later than at present, and that the session shall continue "during such time as may be essential for the transaction and completion of business requiring consideration."

The governor's power to call extra sessions remains as at present, but it is further provided that he must call such extra session upon the written request of two-thirds of the members, such request to indicate the legislation to be considered during the special session.

A straight salary of \$7000 per year per member is allowed with mileage at the rate of twenty cents per mile one way.

Representative Lee introduced a 30-page bill in the house providing for the regulation of the appropriation of the waters of the streams of Arizona.

Speaker Brooks is responsible for another bill introduced today which requires a chauffeur's license and the passing of an examination in the handling of the vehicle by each applicant.

In the senate the measure introduced by Senator Kinney providing for party primaries and requiring voters to state their party affiliations before voting at a primary election, was passed.

Senate bill No. 8, providing for the remitting to liquor dealers of the unexpired portion of their license fees, finally passed.

After pulling the teeth of the senate mothers' pension and old age bill, the house finally passed it this morning.

Goodwin, of Maricopa, moved that new bills be introduced after March 1, and the members joyously turned it down by a vote of 20 to 18.

The governor today signed senate bills Nos. 46 and 36 and house bill No. 38.

Senate bill No. 46 requires registration of vital statistics.

Senate bill No. 36 provides for the reporting of injuries to live stock by railroads.

House bill No. 38 provides that the polls at school elections shall be open from 10 a. m. until 6 p. m.
