PRIMARY RULES.

Democrats To Make Choice For Appointive Officers November 6th.

The state Democratic executive committee, in session in Jacksonville recently, promulgated rules to govern the primaries to be held on November the 6th, next, a synopsis of which is as follows:

An election by primaries is hereby called in each county on November 6th, 1900, to settle the question of the removal of the seat of state government; and also the question of holding a state constitutional convention; and also to nominate candidates for all such appointive offices wherein vacancies shall occur in the next two years; and also candidates for all such appointive county offices that it may be necessary to fill in the next two years.

If no candidate receives a majority vote for any such office, then the two highest candidates shall be voted for at a subseof December, 1900.

the state capital; each such elector shall have the right to vote for or against the calling of a state constitutional convention; and each elector shall have the right to vote for one candidate for adjutantgeneral, and for one candidate for state chemist.

Each such elector in the Second. Third, Fourth and Seventh judicial circuits shall have the right to vote for one candidate for state attorney for his judicial circuit.

Each such elector in Duval, Escambia, Hillsborough, Orange and Volusia counties shall have the right to vote for one candidate for judge and one candidate for solicitor of the criminal court of record for his county.

Each such elector in each county sha!! have the right to vote for one candidate burns without leaving a scar. Wilson & for county commissioner in each com- Son. missioner's district in said county in which a candidate for county commissioner has not heretofore been nominated.

Each such elector in each county in which a supervisor of registration shall not heretofore have been nominated shall have the right to vote for one candidate for supervisor of registration for his county.

Each such elector in the county of Escambia shall have the right to vote for one candidate for custodian of lost timber and lumber, and one candidate for harbor master of the port situated in said county.

Voting in said primary shall be by ballot, prepared in accordance with the state election law, the ticket to include the names of cities which are candidates for the location of the state capital.

Cities desiring to be voted for as a site for the state capital, and all persons desiring to become candidates for appointment to state offices, shall cause their names, together with a statement of their candidacy, to be filed in writing with the chairman of the state executive committee not less than fifty days before the date of said primary election.

Persons desiring to be come candidates for appointment to any county office shall cause their names, together with statements of their candidacy, to be filed with the chairman of the county executive committee at least twenty days before said primary election.

If fraud is perpetrated in the returns, the committee reserves the right to correct such fraud or error.

Each candidate or city entering the primary shall be given the right to place a watcher at the polls from the opening to the closing of the election.

Each county committee shall notify the state committee of the number of electors in each county precinct ten days before the date of the primary.

The county executive committee in each county shall appoint, not less than twenty days before said primary election, three intelligent and fair-minded persons, to be designated as inspectors of election, one of whom shall act as a clerk, in each precinct in said county. Such inspectors shall be paid \$1 per diem, and one of them, acting as a returning officer, shall be allowed an additional compensation of 5 cents per mile for the distance traveled in making said returns and going home, and not more than one additional per diem of \$2 for the time so employed. The chairman of the county executive committee shall, in his published call for such primary election, publish the names of the persons so elected

to serve as inspectors. for the state capital site are hereby assessed the sum of \$1,000 each, provided that if less than five cities qualify for said primary election, then the cities

buted among the different counties in proportion to the number of election precincts in such county, and the balance of the money necessary to defray the expenses of said primary in any county shall be provided by the several county committees by assessments on the various candidates.

Returns shall be canvassed within six days by the respective county committees, to be qualified to the state committee at meeting to be held in Jacksonville on November 20th.

The primary polling place shall, in each precinct, be as near as practicable to the place of holding the general election on said day.
