Don't believe all you hear. The State is due this morning. The El Capitan has arrived out. The Gen. Miles leaves for Tillamook to-morrow morning.

Sol. Russel and troupe will play in Astoria on the 23d inst. But 103 miles of track on the N. P. R. R., remains to be laid. A large party of Portland excursionists went to Ilwaco yesterday on the Gen. Miles.

Nearly three months without a drop of rain. The utmost vigilance is needed as regards fire. Wm. Sexton, Pacific coast manager of the Lion Insurance company is a passenger on the State.

Sol Smith Russel will play in Portland next week, having come west via the N. P. R. R. The camp meeting at Ocean Park, near Ilwaco, begins on the 20th inst., and continues ten days.

A. G. Spexarth will re-open in the building now occupied by W. E. Dement & Co., in a week's time. Extreme forest fires are reported from Tillamook. In the Neacoma region the damage is said to be considerable.

The Portland city council has rejected the nomination of Thos. Connell for chief of police by a vote of seven to two. An extension of the Main street wharf is being built on the Cass street end of the property, thus covering the entire dock.

"In the second year of our organization there were fifteen new lodges and seventy-five members added producing \$1,025 00. In the third year thirty-five new lodges and 1,707 new members, making \$3,457; in the fourth year fourteen new lodges and 722 members increasing our income \$1,403, but this year we have but eight new lodges and 255 new members producing but \$995.

Fire Insurance.

The Coast Review fire insurance chart for 1883, just issued, gives the premiums received and losses paid on the Pacific coast for the year 1880, 1881 and 1882 by all the companies doing a fire insurance business here.

These figures are compiled from the sworn statements of the companies, filed by them in the office of the Insurance Commissioner. From the comparative figures of the different years it appears that fire insurance on the Pacific coast, while increasing in volume, has increased in hazard.

The ratio of losses paid to premiums received in 1882 was 49 per cent; in 1881 it was 35 per cent. As a consequence of this increased ratio of loss ten companies have withdrawn from business on this coast since January 1st. Five of the ten were French companies, one was a Glasgow company and four were companies of eastern states.

The total premium income of these ten companies in this field last year was \$293,501 and they paid for losses \$162,068, or 52 per cent. A Card. Now we, (by which is meant the Italians of this community), are as much in favor of maintaining the law as the best and most law-abiding citizens among which we claim to rank, and when any countryman of ours is guilty of any crime let him be punished for it, and you will find ever ready to assist in maintaining the law and preserving order, but before any crime is charged against us, be sure that we are responsible for it.

We think we are justified in saying, that a very small per centage of the crimes committed in this community have been committed by Italians, although a large per centage of has been charged to them, the injustice of which we keenly feel, and of its injustice, we think every impartial man will be assured.
