The Days of Barter are Over.

At one time, men traded an animal's skin for a stone axe, canoe for a certain amount of labor.

Today there is a medium of exchange by which all things are measured. You do not express the value of your horse in terms of a number of days labor. Your home represents a certain amount of money.
