# MICHIGAN MELANGE.

NEWS OF GENERAL INTEREST TO OUR READERS.

Important Happenings in the State During the Past Few Days Reported by Telegraph—Matter Selected for the Benefit of Our Own People.

Battle Creek, Mich., Oct. 19.—The inter-state philanthropic conference closed Sunday night after six days of sessions, which were successful as to attendance and interest manifested. An address by the Rev. S. Sherin of Chicago, secretary of the conference, created a sensation. His topic was "How to Drain the Social Swamp."

He said the social sewer was the greatest evil of today. In Christianity should lie the cure, but the organized Christian church is a failure. Only 5 per cent of the world is touched by Christianity. The present church does not touch the greater evils. Plans to heal wrongs must be as broad as the wrongs are. In a Chinese city there are twenty-seven Christian sects, but paganism does not know they are there. In Michigan only one man of a dozen goes to church; still many are moved by the spirit of Christ, who are true Christians, although supporting no sects.

Despite adverse criticism, he said, no church is doing so great philanthropic work today as the Catholic. Yet masses, solos, and sermons will never accomplish what is needed; churches burdened with debt cannot easily help others. Intemperance is thriving despite efforts of the church. More beer and whisky are being consumed than ever before. The W. C. T. U. was organized and sent a thrill through the land, but it has gone into political trickery and will never put down the traffic. The Y. M. C. A. meant to do good, but is worldly. It ought to be buried. It is but a corpse. A philanthropic movement it is a fraud, though as a club it is entertaining. There are quarrels over the offices etc., but no real good is done.

Death Springs on Him Unawares and the End Quickly Comes—Sketch of the Life of the Great Car-Builder.

Chicago, Oct. 20.—The circumstances surrounding the death of George M. Pullman, the sleeping car builder, which occurred yesterday, are stated by John S. Runnels, chief counsel for the Pullman company, as follows: "Mr. Pullman died at 5 o'clock yesterday morning of angina pectoris. The extreme heat of last week, together with perhaps more than his usual exertion in showing some friends about Pullman, had caused him a feeling of debility, about which he spoke to one or two friends, but which he did not regard as serious. He told one of them Monday who suggested that he was not looking quite as well as usual that he had been unable to sleep satisfactorily the last two nights, and particularly on Sunday night; that he had some little difficulty in breathing, but that he felt much better then and he felt that a day or two would put him all right.

Physician Came Too Late. "He, indeed, was so well that he intended to leave for New York Thursday evening. Death came to him very quickly. At about 5 o'clock in the morning some friends who were staying at the house heard a noise in his room as if he wished to call some one. They went to his room immediately, and found him standing up and evidently in great pain. One of them went to the telephone to call his physician, Dr. Billings. At the same time he himself attempted to walk to the lounge, but before he reached it required the assistance of his friend to get him to the lounge. He then became unconscious. In the meantime Dr. Billings had arrived at the house and applied restoratives, but without avail, and Mr. Pullman quietly passed away without regaining consciousness."

GOT HIS START AS A CONTRACTOR. Helped Lift Chicago Out of the Swamp—Town of Pullman.

George Mortimer Pullman was born in the village of Brockton, Chautauque county, N. Y., March 3, 1831. He was one of ten children, eight of whom reached adult life. These were Rev. Royal H. Pullman, Albert B. Pullman, George M. Pullman, Charles L. Pullman, Frank William Pullman, Helen A. Pullman, who married George West, a woolen merchant of New York, and Emma C. Pullman, who became the wife of Dr. William F. Fluhrer, a leading surgeon of New York city. George M. received a plain common school education. He first got a position in a store at \$40 a year, and at the end of the first year quit and went with his brother to learn the cabinet makers' trade, finally going into partnership with his brother.

Together they conducted a fairly prosperous business, when the death of their father, Nov. 1, 1853, caused a change in their plans. Upon George, who was unmarried, now fell the care and support of his mother and four of the younger members of the family. This required him to get into something at which he could earn more. The Erie canal, begun in 1817, and finished according to the original plans in 1825, had become inadequate to the demands made upon it, and at this time was being enlarged by the state, which had advertised for contracts for raising buildings along the improved waterway.

He was only 22, but he bid for a contract and got it, and so successfully did he accomplish the work that he was soon ranked with the leading contractors in that line of business, and found no difficulty in getting all the work he could do. In 1859 he removed to Chicago and engaged extensively in the then novel task of raising entire blocks of brick and stone buildings. That year his attention was first directed to the discomfort of long distance railway traveling, and he determined, if possible, to offer the public something better. In 1859 he remodelled two old day coaches of the Chicago and Alton road into sleeping cars, which at once found favor and established a demand for improved traveling accommodations. In 1863 he began the construction at Chicago of a sleeping car; upon the now well-known model, which was destined to associate his name inseparably with progress in railway equipment.

It was named the "Pioneer" and cost about \$18,000. From this small beginning he continued to develop his ideas for comfort and safety in railway travel, till Pullman cars are now known all over the world. The Pullman Palace Car company, of which he was president, was organized in 1867, and it now operates over 1,400 cars on more than 100,000 miles of railway. In 1887 he designed and established the system of "vestibuled trains," which virtually makes of an entire train a single car. They were first put in service upon the Pennsylvania trunk lines, and are now to be found on many other railroads.

In 1880, in obedience to the imperative demand of the Pullman company for increased shop facilities, and to give effect

to an idea he had long cherished of improving the social surroundings of the workmen, he founded near Chicago the industrial town of Pullman, which now contains over 11,000 inhabitants, 5,000 of whom are employed in the company's shops. Architecturally the town is picturesque, with broad streets, handsome public buildings, and attractive houses, supplied with every modern convenience for the employes. According to mortality statistics, it is one of the most healthful places in the world. Mr. Pullman had been connected with various public enterprises, among them the Metropolitan Elevated railway system of New York, which was constructed and opened to the public by a corporation of which he was president.

Blanco Has Sailed for Cuba. Madrid, Oct. 20.—A dispatch from Corunna says that Marshal Blanco, the newly appointed general of Cuba, sailed for Havana yesterday.

New Factory at Menominee. Menominee, Mich., Oct. 16.—The Richardson Shoe company, capitalized at \$45,000, was organized Thursday and the following directors elected: S. M. Stephenson, J. W. Wells, John Harris, M. S. Harmon, G. A. Bleach, Alexander Richardson, and Philip Harter. A large factory will be erected on a site in the northwestern part of the city and will give employment to 150 hands. The machinery of the Norcross, Richardson plant at Janesville will be moved here and the new factory put in operation under the management of Alexander Richardson, about Jan. 1.

Killed by a Fall of Ground. Ironwood, Mich., Oct. 20.—John Bloomstrom, ex-sergeant of police and one of the most prominent Scandinavians of this section was instantly killed by a fall of ground at the Newport mine yesterday morning.

Coming Marriage Announced. London, Oct. 20.—The Times announces the approaching marriage of Lord Mount-Stephen, formerly president of the Canadian Pacific railway, to Gladys, daughter of the late Robert George Tufnell. The announcement has caused much interest in Canadian circles. Lord Mount-Stephen, in addition to serving as president of the Canadian Pacific railway, having been a director, vice president and president of the Bank of Montreal and president of the St. Paul and Manitoba railroad. Lady Stafford Northcote, the adopted daughter of Lord Mount-Stephen, has been hitherto recorded as the latter's heir.

In 1859 he removed to Chicago and engaged extensively in the then novel task of raising entire blocks of brick and stone buildings. That year his attention was first directed to the discomfort of long distance railway traveling, and he determined, if possible, to offer the public something better. In 1859 he remodelled two old day coaches of the Chicago and Alton road into sleeping cars, which at once found favor and established a demand for improved traveling accommodations. In 1863 he began the construction at Chicago of a sleeping car; upon the now well-known model, which was destined to associate his name inseparably with progress in railway equipment.

It was named the "Pioneer" and cost about \$18,000. From this small beginning he continued to develop his ideas for comfort and safety in railway travel, till Pullman cars are now known all over the world. The Pullman Palace Car company, of which he was president, was organized in 1867, and it now operates over 1,400 cars on more than 100,000 miles of railway. In 1887 he designed and established the system of "vestibuled trains," which virtually makes of an entire train a single car. They were first put in service upon the Pennsylvania trunk lines, and are now to be found on many other railroads.

In 1880, in obedience to the imperative demand of the Pullman company for increased shop facilities, and to give effect

to an idea he had long cherished of improving the social surroundings of the workmen, he founded near Chicago the industrial town of Pullman, which now contains over 11,000 inhabitants, 5,000 of whom are employed in the company's shops. Architecturally the town is picturesque, with broad streets, handsome public buildings, and attractive houses, supplied with every modern convenience for the employes. According to mortality statistics, it is one of the most healthful places in the world. Mr. Pullman had been connected with various public enterprises, among them the Metropolitan Elevated railway system of New York, which was constructed and opened to the public by a corporation of which he was president.

Blanco Has Sailed for Cuba. Madrid, Oct. 20.—A dispatch from Corunna says that Marshal Blanco, the newly appointed general of Cuba, sailed for Havana yesterday.

New Factory at Menominee. Menominee, Mich., Oct. 16.—The Richardson Shoe company, capitalized at \$45,000, was organized Thursday and the following directors elected: S. M. Stephenson, J. W. Wells, John Harris, M. S. Harmon, G. A. Bleach, Alexander Richardson, and Philip Harter. A large factory will be erected on a site in the northwestern part of the city and will give employment to 150 hands. The machinery of the Norcross, Richardson plant at Janesville will be moved here and the new factory put in operation under the management of Alexander Richardson, about Jan. 1.

Killed by a Fall of Ground. Ironwood, Mich., Oct. 20.—John Bloomstrom, ex-sergeant of police and one of the most prominent Scandinavians of this section was instantly killed by a fall of ground at the Newport mine yesterday morning.

Coming Marriage Announced. London, Oct. 20.—The Times announces the approaching marriage of Lord Mount-Stephen, formerly president of the Canadian Pacific railway, to Gladys, daughter of the late Robert George Tufnell. The announcement has caused much interest in Canadian circles. Lord Mount-Stephen, in addition to serving as president of the Canadian Pacific railway, having been a director, vice president and president of the Bank of Montreal and president of the St. Paul and Manitoba railroad. Lady Stafford Northcote, the adopted daughter of Lord Mount-Stephen, has been hitherto recorded as the latter's heir.
