ACTORS ORGANIZATION THREATENS TO STRIKE
 1,600 of Best Talent in Country Make Demands.

New York, June 4.—The Actor's Equity association, which comprises some 1,600 of the best talent in the country, has been quietly obtaining pledges from its members to go on strike if the big managers will not come to time and agree to give contracts suitable to the association.
 Already 850 actors have given their word to stand by the demands of the association and walk out if these demands are not acceded to.
 It is the first time in the history of the American stage that any concerted movement on the part of the actors has been made against their managers. The actors are trying to secure a uniform standard of contract which can, if need be, be taken into court with some hope of success. They are also trying to secure an agreement to certain conditions under which actors may be engaged, and they are trying to obtain full pay for their members during Christmas week and Holy week which are said to be the most disastrous weeks in the whole year for members of the profession.
