### FINALLY

The Springfield Reporter makes the suggestion that the state papers "engage upon a campaign of education which will result in an enforcement of the liquor law, and recruits to the practise of total abstinence, such as the state has never seen." We have already said, and the fact is worth emphasizing, that last Tuesday's decisive no-license vote in the state as a whole coincident with the vote against the enactment of statewide prohibition, is conclusive proof that the sentiment of Vermont in favor of temperance and against the evil of liquor selling, was never stronger than today. And there was never a time when it was more clearly the opportunity and the duty, not only of the newspapers, but of everyone who believes in temperance law enforcement, to actively support and strengthen this sentiment.

The local-option law will only become weakened and ineffectual when we become indifferent about its enforcement and look with lenience upon offences against it. Here in Windham county public sentiment not only approves, but demands its strict enforcement. The only danger now is that under last week's overwhelming vote we may grow less watchful. The justification for the vote against a prohibitory law must come through a constant and impartial enforcement of our present law. Not only must bootleggers and obscure dives be summarily dealt with, but there must be no favoritism toward infractions higher up—not if we want public sentiment to stay behind the law. It was rottenness of enforcement which killed the old prohibitory law, and the same state of things, if allowed to creep in, will kill the local-option law in due course.

Beyond this, the really essential point: We have had a long time of writing and talking and preaching about liquor laws and methods for control, and we have found out what the people of Vermont want. Now let press and pulpit, and spellbinders and men and women, in precept and practice, put the emphasis where it belongs on the inculcation of temperance principles that mean something and against habits and practices which spell ruin in the end. The final responsibility is on us all as individuals, and not on the law.

### MEXICO IS INVADED

#### Army of 5,000 Has Crossed the Border to Wipe Out Villa

Gen. Funston in Command and Gen. Pershing Leading Attacking Force—Army Increased to 120,000.

The attack of Villa and his bandits on Columbus, New Mexico, with a loss of the lives of 16 Americans, soldiers and civilians, as reported in The Phoenix last week, has been followed by prompt action in Washington and along the border, and an army of fully 5,000 American soldiers are now invading Mexico under instructions to kill or capture Villa and his horde. Villa lost over 100 men in the fight at Columbus, and Major Tompkins, formerly commandant at Norwich university, pursued the retreating invaders several miles into Mexican territory.

President Wilson gave on Saturday orders for the mobilization of an army to wreak vengeance on Villa. The Carranza troops are also on the trail of the outlaw. The American invasion at this time does not mean intervention in Mexican affairs, but the wiping out of the band which has been a menace to border towns in the United States.

The object of the raid on Columbus was undoubtedly to provoke the United States into intervention.

Action was taken in the house at Washington Tuesday and in the Senate Wednesday, in both cases almost unanimously, to increase the regular army by 20,000 men, or to a total of 120,000. Recruits are now being accepted at many stations in different parts of the country. The new soldiers will be used for border patrol, while the more experienced soldiers will join in the punitive expedition in Mexico.

Gen. Frederick Funston is in supreme command, and his headquarters are in San Antonio. The army crossed the border Wednesday, with Gen. Pershing in command. The main force left Columbus, with a column of cavalry under command of Col. Debs, formerly at Fort Ethan Allen, starting from a point further west.

Gen. Funston has imposed a strict censorship, so that news of the movements of the troops cannot be sent to Villa from this side of the line.

Villa is reported to be breaking his men into small bands. They will have an opportunity to hide in the mountain fastnesses and it is probable that it will require several months to exterminate his bandits. The death of the capture of Villa at an early date would do a great deal toward ending the invasion quickly. There has been some talk that Carranza soldiers had revolted and would flock to Villa, and that Zapata and Diaz, opponents of Carranza, were sending 1,000 men to aid Villa. If there should be a general uprising of Mexicans against the American soldiers serious complications might easily arise, but Carranza himself is favorable to having the United States attack the bandits.

### STORM BLOCKS ROADS

#### Snowfall Only About Eight Inches, but Wind Makes Drifts

Rural Carriers Curtail Routes—Stage Routes Affected—Trolley and Railroad Service Fairly Continuous.

The storm Wednesday succeeded in tying up traffic on the highways and byways of this part of Vermont more effectively than any previous storm of the winter. Only a little over eight inches of snow fell, but the trouble was caused by the high wind which whirled the light snow into drifts that packed in every hollow.

Frank O. Johnson, one of the rural carriers, reported that he covered Wednesday the smallest part of his route that he ever covered on one trip in his experience of about 10 years. It was impossible for him to make headway against the wind and through the drifts.

All of the rural carriers reported great difficulty in making progress and very one of them had to curtail his route. The Wilmington stage driver got in from Wilmington a little after 12 o'clock Wednesday morning, about two hours late, and the Jacksonville stage, due about 10 o'clock in the morning, reached the postoffice at 1. Neither attempted to make the return trip that day, but started back yesterday morning.

The trolley service was fairly continuous and in the afternoon and evening the cars ran most of the time on schedule or very near it. The early trips yesterday were made according to schedule.

The 4:23 p. m. train from the north Wednesday was one hour and 45 minutes late and the 5:36 afternoon train from the south did not get in until nearly 6:30 o'clock, but these two trains were the most affected by the weather, allowing that the "owl," southbound early in the morning, was late as usual.

The roads where the wind had a sweep both day and night were badly drifted yesterday and in some of the outlying districts it will be a day or two before anything resembling ordinary conditions for travel will be approximated.

The eight and one-quarter inches of snow that fell Wednesday made a total of 27 inches for the month of March to date and a total of 75 3/4 inches for the winter, according to the records kept by Morris E. Vaughan.
