FINDS AUTO UPSIDE DOWN ON LYNDON ROAD

W. H. Jeffrey Unable to Solve Mystery of Motor Car Accident

W. H. Jeffrey, state secretary of the board of charities, saw an automobile turned upside down about two miles from Lyndon on the Wheelock road Sunday night when returning from that town. The car was turned turtle and had been forced between the end of a culvert and a tree. The clothing of the occupants was strewn about the place and the tools of the car likewise, while the car was badly damaged. The appearance was that some automobile party following had taken the persons in the car to a hospital.

Although the Ford was upside down the rear light was burning. The car is registered to C. H. Lamphere in Windsor. There was a hat which was apparently bought a day or two before at Silby's store in Lyndonville. No report of the accident had been received at the secretary of state's office Monday morning. It has been learned that the Ford car which W. H. Jeffrey found wedged in between a ledge and a culvert near Lyndonville Sunday night was driven by Roy Watkins of Windsor, who in company with another man hired the car the middle of last week to go to the northern part of the state. The two men arrived in Windsor Tuesday morning none the worse for the mishap, which resulted in the car being turned turtle. They gave no reason for the abandonment of the car and the secretary of state's office is investigating the accident.

DANVILLE Death of Fred Bernard Stocker. In the death of Fred Bernard Stocker, the town loses one of its most prominent and influential business men. He had been ill with heart trouble for several months and the end came Tuesday afternoon, Oct. 26. Fred B. Stocker was one of the twin boys of Newell and Cynthia Dole Stocker and was born Nov. 7, 1854 at the old Stocker homestead on the St. Johnsbury road. When nine years of age his parents moved to the farm just below the depot which has since been his home. For many years he has been associated with his brother Frank D. Stocker in business dealing in grain, flour, coal and stock and they had charge of the local stock yard. He was vice president and director of the Caledonia National Bank and was a man deeply interested in the best interests of the town and community.

He was town representative from 1894 to 1896 and had held other town offices. Sept. 16, 1878, Mr. Stocker was married to Miss Carrie E. Stanton. To them were born two sons, Fred B. Stocker Jr., who died Dec. 18, 1900, aged 21 years, and Marshall M. Stocker. Mr. Stocker was a man deeply devoted to his home and family and was highly respected by all with whom he came in contact. He leaves beside his wife and son, Marshall, a sister, Mrs. Flora G. Stevens of Oakland, Calif., and his brother, Frank D. Stocker of this town.
