COURT'S DECISION.

STATE OF MICHIGAN—The Circuit Court for the County of St. Clair.

Leslie Silverthorne, Relator, vs. George McIntyre, George Gardner, William Ernest, Elijah Bricker, Thomas U. Wharton, R. Bruce Lothian, and Aaron Windsor, the Mayor and the Common Council of the City of Yale, Respondents.

This is a hearing upon an order issued by this court requiring the Mayor and the Common Council of the City of Yale to show cause why a peremptory mandamus should not issue requiring them to meet and reconsider the action formerly taken by them approving the application and bond of James Wesley Harrington to engage in the retail liquor business in the City of Yale, and to vacate and set aside the same, and to reconsider relator's application for a retail liquor license, and if found without legal objection, to approve the same. An answer has been filed by George McIntyre, Mayor of said city, joining with him two of the six aldermen of said city; a separate answer has been filed by the remaining four aldermen. Issues have been framed and testimony taken in open court.

FACTS.

There is no dispute regarding the material facts in this case. The city of Yale is an incorporated city of the fourth class under the laws of this state. Under the laws relating to the sale of intoxicating liquors, its population, as shown by the last United States census, entitles its Common Council to grant two and only two applications for the sale of intoxicating liquors at retail. Prior to the 14th day of April, 1915, Jerry B. Paisley, James Wesley Harrington, and the relator, Leslie Silverthorne, filed applications with the Common Council of the city of Yale, asking that they be granted the privilege of carrying on the business of selling and offering for sale intoxicating liquors at retail within the city of Yale for the year commencing May 1, 1915, and ending on April 30, 1916. These applications were all accompanied by properly executed bonds. At a meeting of the Common Council for said city, held on the 14th day of April, 1915, the applications of Jerry B. Paisley and James Wesley Harrington were granted and their bonds approved. No action was taken upon this application and bonds of relator at this time or later. The relator possessed the legal qualifications required by statute of a person to engage in the sale of intoxicating liquors at retail within this state. James Wesley Harrington, one of the said applicants, did not, within two weeks from the 14th day of April, 1915, file his approved application and bond with the county treasurer of St. Clair county, and pay to the said county treasurer the license fee required as provided by Section 4, of Act 291, of the Public Acts of 1909.

On the 22nd day of April, 1915, the relator, Leslie Silverthorne, caused to be withdrawn from the custody of the city clerk of the said City of Yale, the application, theretofore filed by him, and on the same day filed another application in proper form with said city clerk, asking that he be granted the privilege of carrying on the business of selling and offering for sale intoxicating liquor at retail within the said City of Yale for the year beginning May 1, 1915, and ending April 30, 1916. Said relator did not withdraw his properly executed bond which he had filed prior to April 14, 1915, but left said bond with the city clerk. On the 30th day of April, 1915, the said James Wesley Harrington filed another application in proper form with an accompanying bond duly executed with the city clerk of the City of Yale, asking that he be granted the privilege of carrying on the business of selling and offering for sale intoxicating liquors at retail within the said city for the year beginning May 1, 1915, and ending April 30, 1916.

On the 30th day of April, 1915, the Common Council of the said city of Yale, at a special session, rejected relator's application filed on April 22, 1915, and approved the application and bond of James Wesley Harrington filed on April 30, 1915.

At a regular session of the Common Council of the City of Yale, held May 2, 1915, the following ordinance was passed:

An ordinance regulating the location of saloons in the city of Yale Michigan. The Common Council of the City of Yale Ordains: Section 1. No person shall engage in the business of saloon keeping in any house or place within the limits of the City of Yale, without first having obtained a license for that purpose from the Common Council.

Section 2. All bars, hotels, saloons and other places for the sale of intoxicating liquor at retail in the City of Yale, shall be located on either side of Main street between North and Wood streets so-called.

Section 3. It shall be unlawful for any person to engage in the sale of intoxicating liquor at retail at any place or location other than designated in section 2 of this ordinance and the Common Council shall not have the right or authority to grant a license to conduct the sale of intoxicating liquor at retail in any place other than is designated in section 2 of this ordinance, on conviction thereof shall be punished by a fine not more than one hundred dollars and costs of prosecution, or by imprisonment in the county jail for a period not to exceed ninety days, or both such fine and imprisonment within the discretion of the court.

Section 4. This ordinance shall take effect on the 25th day of May, A. D. 1915.
