While the Milwaukee Responds Merrily and the Northwest Goes in for Keep.

The Pluck Movement of the Milwaukee Suddenly Ends Peace Negotiations.

Hughtit to the Line, Let the Chips Fall Where They May.

The War Goes On. Special Dispatch to This Issue.

NEW YORK, November 28.—It is difficult to ascertain the exact status of the railway war. Vice President Wadsworth, of the St. Paul road, said this afternoon, "We received a proposal from Mr. Keop, of the Northwestern, which we thought was fair and favorable to all, and we at once heartily concurred in it, as did all other companies. I had supposed that was the last of it, but now Porter, of the Omaha, goes to work and kicks it all over. Now we are done. If there is war let it go on. We have done nothing to-day to secure harmony, nor do we intend to do anything."

Keep, president of the Northwestern, at his office on Wall street, in reply to inquiries said, "I entered into the matter, not because my company was the greatest sufferer, but because I was anxious to see harmony. The plan he had proposed he thought was a good one and all seemed to favor his view, at least he expressed themselves. The action of the Omaha's president in drawing out of the pool did not need discussion." Keep said he would make no further efforts to bring about peace. He has no business to finish up with the directors this afternoon, and to night he and General Manager Hughtit will start on their return to Chicago. The report that Porter has requested the presidency of the Omaha road was promptly denied at the office of the company. Although the indications are not as favorable as yesterday, the strength of stocks is taken as a sign that the railway war is not lost as a power to influence the entire market.

President Porter, of the Omaha road, says: "I had agreed to enter this conference after a great deal of wringing. Negotiations have been going on for several days, and when I discovered last night that the St. Paul had gained control of this road, I withdrew at once from the conference, or, rather, refused to take part in it, and will not agree to any new conference until I know whether the St. Paul people decided me in Chicago on the last night in this city. When, during the day, a flag of truce is displayed, and under cover of that flag of truce our army takes steps to place troops as to threaten the ranks of opponents, their opponents have the right to renew hostilities at once. That is what the Omaha road has done. Should another conference be arranged, the arbitration committee shall determine whether or not this move of the St. Paul people was made before these fresh negotiations were begun and treat it accordingly. I have waited here in this city some days, in expectation that this question would be settled, but I shall go to Chicago to-night."

It is claimed the seaboard trunk lines have been getting more than just proportion of the entire rate. They will meet again to-morrow. We have done nothing to-day to secure harmony, nor do we intend to do anything."

Keep, president of the Northwestern, at his office on Wall street, in reply to inquiries said, "I entered into the matter, not because my company was the greatest sufferer, but because I was anxious to see harmony. The plan he had proposed he thought was a good one and all seemed to favor his view, at least he expressed themselves. The action of the Omaha's president in drawing out of the pool did not need discussion." Keep said he would make no further efforts to bring about peace. He has no business to finish up with the directors this afternoon, and to night he and General Manager Hughtit will start on their return to Chicago. The report that Porter has requested the presidency of the Omaha road was promptly denied at the office of the company. Although the indications are not as favorable as yesterday, the strength of stocks is taken as a sign that the railway war is not lost as a power to influence the entire market.

President Porter, of the Omaha road, says: "I had agreed to enter this conference after a great deal of wringing. Negotiations have been going on for several days, and when I discovered last night that the St. Paul had gained control of this road, I withdrew at once from the conference, or, rather, refused to take part in it, and will not agree to any new conference until I know whether the St. Paul people decided me in Chicago on the last night in this city. When, during the day, a flag of truce is displayed, and under cover of that flag of truce our army takes steps to place troops as to threaten the ranks of opponents, their opponents have the right to renew hostilities at once. That is what the Omaha road has done. Should another conference be arranged, the arbitration committee shall determine whether or not this move of the St. Paul people was made before these fresh negotiations were begun and treat it accordingly. I have waited here in this city some days, in expectation that this question would be settled, but I shall go to Chicago to-night."

Alex's Assertion. Special Dispatch to This Issue.

MILWAUKEE, November 28.—Alexander Mitchell to-night said the meeting at Chicago had not been called relative to the rate war, and Porter's excuse to the effect that owing to the St. Paul's purchase of the Chippewa Valley & Superior road hostilities might be prolonged, was merely a scheme to evade direct issues.

Troubles of the Pool. Special Dispatch to This Issue.

CHICAGO, November 28.—Representatives of the roads composed in the northwestern pool, met in secret to-day and discussed the grievances arising out of the large number of cheap tickets in the hands of scalpers issued during the war a year ago between Chicago, St. Louis and Kansas City. As some of the roads in the pool were not represented, adjournment was taken till to-morrow. Subsequently a meeting of representatives of roads in Iowa, Trunk Line association was held. George Olds, of the Missouri Pacific, was appointed arbitrator on lumber. Pool Commissioner Middleley and freight agents of the association roads appointed a committee to go to New York to confer with the eastern trunk line managers on pro rate of through business from San Francisco in co-operation with steamship lines. It is claimed the seaboard trunk lines have been getting more than just proportion of the entire rate. They will meet again to-morrow. It is understood neither association took any action relative to the war in the northwest.
