The New Atkins School.
 Architect Ward, of the new Atkins school building, yesterday showed a BEE representative through that handsome structure. The work is now so nearly completed that one may obtain a very correct idea of what its appearance will be when finished. It is expected to have all wood work on the third floor finished this week, so that the painters may begin there the first of next week. With the exception of putting on the finishing touches, the wood work will be completed this week, and the painters and stainers will have full swing next month, when the entire structure is to be finished.

The Hotels and Union Depot.
 The union depot project numbers among its staunchest supporters the hotel men of the city. These gentlemen are so constantly brought in contact with the traveling public that they know the prevailing impression among that class regarding the railroad facilities now offered here, and the wretched shells that are made to serve as depots. Said one of the leading hotel men of the city yesterday: "The one thing that is working more against this city than anything else is the wretched accommodation furnished travelers by the railroad companies whose lines run in here. It is an actual fact that porters as the sleeping cars, brakemen, conductors, in fact all railroad employes on any of these lines, advise passengers from the east to go to Omaha. They tell them of the wretched depots here, and the difficulties attendant on getting to the hotels, and the result is that we are virtually frozen out of much business that we would otherwise have. If you would stop so thoroughly disgusted that they swear that they will never stop in the city again. If you could stand behind a hotel desk for twenty-four hours he would hear enough to convince him that I am telling things as they actually exist. Aside from the depots themselves, the poor transportation from them to the central part of the city. Take the evening trains, for instance. The trains on nearly all of the roads come in at about the same time, and if a train is a little late there is no way of getting up town, except to walk, and that is far from agreeable during a heavy rain or snow storm. The street cars do not make connections with late trains, and the hackmen do not always have a horse and buggy to see them come in drenched by the rain and covered with mud you would not blame them if they cursed the city to the end of their days."

"But the greatest source of annoyance is the transfer, under the manner in which business is now conducted, of a trunk is checked to Council Bluffs, it is invariably sent to the transfer unless its owner distinctly specifies the local depot, and even then it is frequently carried by rail and transferred after all. Then is where the trouble comes in. None of the hackmen pretend to make the transfer, and if they frequently happens that baggage can not be obtained from there until the following day after its arrival. Many is the 'roar' I have heard on this account, and have sometimes helped the irate guest kick."

"Anyone can readily see that a man will not put up with this sort of a thing many times, and so it is that the hotels directly, and the city indirectly, lose a great deal of business that naturally belongs here. We are located to receive a great many transient guests who are crossing the continent, and we would get them if we had a union depot. Hackmen would then be able to meet and transfer and baggage would be left where it could be obtained. Business that helps a hotel helps a city as well, and this union depot would help us wonderfully in that respect. Ask any hotel man in the city concerning the disadvantages offered by the present system, and I will guarantee that he will answer you what I have said. Travelers are disgusted with the looks of the local depots, and go over to Omaha if they can possibly do so. If the business men could only understand how great a detriment the present system is to this city, I am positive that it would not be long until the proper steps would be taken to secure the desired structure."
