Stacy reported that he had made arrangements with H. G. McGee for the purchase of lots 1, 2, 3 and 4, block 3, Sunny Side addition, for \$1,500, on which condition McGee should furnish a good abstract to the title, and should have all the alieys adjoining the property vacated.

The report was concurred in.

Mr. Schoentgen offered a resolution authorizing the committee on buildings and grounds to purchase a site for a new school building, and authorizing the president and secretary to sign a warrant for the amount.

The resolution was adopted.

C. & N. W. ANNUAL MEETING. Dividends Declared on Both the Preferred and Common Stock.

Chicago, June 4.—At the annual meeting of the stockholders of the Chicago & North-western company today the report for the year ending May 31 (the figures for May being estimated) was read. It showed: Net earnings, \$3,676,000; amount paid on dividends, \$1,440,000, leaving a surplus of \$2,236,000, which, added to the amount of the line stock of the Missouri
