SOMETHING MUST BE DONE TO SAVE IT

Repairs Made So Far Have Availled but Little - Suggested that the City's Sandbank Be Used in Filling the Unsightly Holes.

Much dissatisfaction is raised over the condition of the streets paved with cedar blocks. Many, such as Bryant, North Second and Pearl and some of the alleys, like the one running past the city building from Bryant to North Main, are in such condition as to be almost impassable for teams.

Another year or two, at most, will finish the work of destruction, and the streets will have to be repaired or become unfit for travel. Just what should be done is a question that is perplexing some of the officials.
