RETURNS FIVE INDICTMENTS

Grand Jury Presents Its First Report for the Current Term.

TWO BILLS FOUND AGAINST GREGORY

DES MOINES, Nov. 21.—(Special Telegram.)—Smallpox in Buena Vista county is spreading. Four cases and one death were reported from Sioux Rapids to the State Board of Health this morning. One case from Sioux Rapids, three from the country southeast of there and ten from Storm Lake were reported yesterday.

The Catholics of Eldora dedicated a \$6,000 church Sunday. Several cases of diphtheria in the asylum for the insane at Independence. Miss Mary Talbot of Williams has gone to Dubuque to serve as a nurse in the army hospital.

A Cass county man claims to have gathered 40 bushels of corn from seven acres of ground. Lamont Patterson of Washington died as the result of injuries received in a runaway by four demoralized men.

The little child of Joseph Crown was scalded to death by its sister spilling boiling coffee over her head. Chariton boy, slipped while attempting to get on a wagon loaded with coal. The wheels of the wagon passed over his head, killing him instantly.

A runaway team ran squarely into the side of a passenger train on the Iowa Central road near Dillon. No damage was done to the train, but the horses and wagon were badly demoralized.

NEW YORK, Nov. 21.—A appeal to the Tribune from Washington says: Governor Leary of Guam, or "the Isle of Guam," as it is called on the official seal, is having novel experiences for an American in an altogether unique community, but the infrequency of communication with the outside world makes it difficult to reach Washington regarding this innovation in colonial establishments.

Governor Leary was always a picturesque character in the service and his mission in the lonely and scarcely known island was generally regarded as a noble work. It was singularly appropriate, it was expected that an interesting experiment in civilization would begin when he assumed absolute control of the new possession, and so it has turned out, although the Navy department has refrained from interfering with the details of his reports to get into circulation. That these reports are highly interesting and in some instances wholly unconventional is evident from portions of one which has just come to Washington. In this Governor Leary has proposed two of his recent orders to the citizens of the Isle of Guam which are unlike any other orders ever issued by a naval officer.

The report, which is dated October 11, gives a terse resume of affairs in the capital of the island since the last mail. It shows that the islanders are inordinately lazy, having acquired the habits of their ancestors of raising only such crops as will keep their bodies and souls together and that they cannot be easily induced to value money or exercise their earning power. With a minimum of exertion they are satisfied if they do not starve. The whole island is full of examples of neglected opportunities which are so disastrous to Americans.

The governor has set out to bring the people of Guam to a realization of the national wealth of the island and to make all under his jurisdiction as productive as possible. He tells the Navy department that he does not want any more marines sent to him, as he cannot provide food for them and does not need them for his defense, as he has nothing to fear from natives. He begs, however, for more officers to assist him in carrying out his plans for improving the condition of the population.

He says he wants an ice machine, none of the water on the island being potable to the people. He has established the seat of government at Agaña six miles from Agaña, and over this distance his men have had to haul all the materials for the buildings they are erecting, as well as all supplies.

But the interesting part of the report relates to the reforms begun, of which the governor says: "Having disposed of the priests, rapid progress will be made and no further resistance will be encountered."

He explained the two orders which were printed in English in the customary form on the first English printing press in the islands and distributed broadcast. The first of these is calculated to compel each adult native to contribute to the support of the government by engaging in food production. This order was dated October 4 and directs:

RETURNS FIVE INDICTMENTS

Grand Jury Presents Its First Report for the Current Term.

TWO BILLS FOUND AGAINST GREGORY

Charged with Stealing a Mule and Assaulting with Intent to Kill—Youngster Sent to the Penitentiary.
