HARMONY IN THE WESTERN

Denver Meeting Reveals League Magnates Working Well Together.

WHITFIELD ANNOUNCES PLAYERS SIGNED

Packard Declines to Say Whether Season Will Open East or West, but Probability Favors Latter.

DENVER, March 13.—(Special Telegram.)—The harmonious meeting of the magnates of the Western league was brought to a close today and the visiting ball men returned to their homes, where considerable work previous to the opening of the season awaits them.

The league does not desire to fall into the error of the past and revise its schedule after publication. There will necessarily be a conflict of dates at Kansas City and Milwaukee, but the Western league magnates feel that Nichols and Duffy will be able to hold their own in both cities.

Mr. Packard would not say whether the season would open up here or in the east. However, it seems that good judgment would dictate having the season open up west on account of the evenness of the weather.

The maximum rates of mail pay are provided by the ship subsidy bill and authorized by act of 1901. In some instances the maximum rates are higher than the rates provided by the act of 1901.

A corresponding increase in American shipbuilding for several years, involving reductions in relative cost of construction in regard to the mail pay for mail contracts than the maximum rates fixed by the pending bill, but such increase in shipbuilding will not affect the rates of general subsidy under that bill.
