COMPENSATION ACT DESCRIBED FOR BALLOT

 LINCOLN, July 31.—(Special.)—On request of Secretary of State Watt, Attorney General Martin has prepared a form for the referendum ballot on the employers' liability act. It will go on the ballot as follows:

"The purpose of this act is to prescribe the liability of employers, to establish an elective schedule of compensation for injuries received by employees in the course of their employment, to modify common law and statutory defenses and remedies in such cases, to regulate the procedure for determining such liability and to provide the methods for paying compensation thereunder. When employer and employee elect to embrace its provisions this act applies to every employer employing five or more persons, including the state and its governmental agencies, except employers of household servants, farm laborers and railroad companies subject to congressional regulation."

YORK FARMER COMMITS SUICIDE BY HANGING

 DES MOINES, July 31.—(Special Telegram.)—State officials and shippers in Iowa are highly elated over the decision of the Interstate Commerce commission today in what are known as the Iowa cases. The decision in the Mississippi river cases was a general reduction of rates to all points in Iowa because of the order to reduce rates at some of the leading crossing points to correspond with rates to St. Louis and Quincy. Members of the railroad commission figure it will mean many thousands of dollars saved to shippers in Iowa.
