Time to Spray

"It is time to spray," says Williamson of the State Board

of Horticulture, in discussing the care of fruit trees and vines. He is engaged in sending out the formulas for spraying for the San Jose scale, woolly aphis, codling moth and other things that prey on the fruit crop of Oregon.

"Now is the time for winter spraying and it ought to be done right away," he said. "Where the trees are not worth spraying they should be cut down and burned, so as not to remain breeding places for the various pests. Even rose bushes ought to be sprayed, in order that they may not harbor the San Jose scale."

CITY NEEDS WATER

Naftzger Favors Organization
of Municipal Water Users'
Association

A. H. Naftzger, president of the Klamath Development company, arrived in the city Saturday evening to remain several days. While the occasion of the present visit is simply a matter of special business, he expects to return later to inaugurate their plan of work for the coming season.

When asked as to whether he was in favor of the proposition to organize a city water users association for the purpose of supplying water to the city property owners for irrigation, Mr. Naftzger said: "I have heard something about the proposition but do not know just what plan is proposed. We certainly need water to irrigate our lawns and gardens and our company is ready to encourage any movement in that direction. If there is any opportunity to secure a supply of water for this purpose, it would be the gravest mistake we could make as a city, not to take advantage of it before it is too late. I will make it a point to see what the government officials offer to do and if it is a suitable plan I will be glad to co-operate with the citizens."

would result from a perpetual supply of water for irrigation.

The meeting was called to order by G. W. White and on motion L. F. Willits was chosen chairman and J. G. Swan secretary. Engineer D. W. Murphy was asked to explain the plan the Reclamation service followed in supplying cities with water. Mr. Murphy stated that the usual procedure of the department was to enter into a contract to deliver water at a stated point from which the association of citizens a greed to distribute it to the property owners. He called attention to the fact that there are some 40 water rights in the city, which are entitled to one inch of water each, and that some arrangement would have to be made to take care of these.

The remainder of the evening was spent in general discussion of the subject, every speaker strongly urging that action be taken in securing water. The collection of taxes for 1907 has commenced. The tax roll was turned over to the sheriff this morning and he and Deputy Delap are busy making out receipts for those who have sent their taxes in by mail.

The roll this year shows an assessed valuation of \$7,582,950 as against \$6,094,094 for 1906, or an increase of nearly one and one half million dollars. The taxes to be collected are \$143,542.16 as against \$104,106.50 for 1906, and are classified as follows: state, county, school and other tax, \$108,958.04; city tax, \$8,958.72; road tax, \$10,014.07 and special school tax, \$15,911.34.
