It looks as if the Republicans would make a clean sweep in Klamath County this year, but still there may be one or two Democrats slip in.

The fire boys selected a ticket for the city offices and will work for the nomination of their men. It is to be hoped that it won't be necessary to use the hose in order to win on election day.

Another franchise for a power transmission and telephone line is to be granted by Klamath Falls. Our city will soon be well wired, and if they continue it may be necessary to provide for underground-wires.

It is almost time for the excursions on the Upper Lake to commence. There have been so many new boats built the past year that the Pelican Bay resorts will undoubtedly be very popular this summer and well patronized.

Mayor Bishop is in favor of an occupation tax. He does not believe in singling out the draymen for this favor, but thinks all businesses should be treated alike. The income from the real estate men alone would create quite a fund.

It looks as if the much discussed "ice famine" will be with us this summer. Some of the hardware merchants have cancelled their orders for refrigerators, as they claim there will be no ice for sale in Klamath Falls this summer.

Before the City Council order water mains put in promiscuously on the streets in the unprotected districts, it might be well to consider the matter carefully. It will be found cheaper to adopt a system and put in the mains along certain streets from which it will be most convenient to run laterals so as to cover the most territory. The city has no money to waste on improvements and any made should be permanent.

Klamath County is as well equipped with a telephone system as probably any county in the state. This convenience was forcibly demonstrated Friday, when the people of Merrill, 22 miles distance, discovered that through an oversight they were without poll books. This was discovered about 12 o'clock, when the poll should have opened. By the use of the phone and a motor cycle, the supplies were on the ground only an hour late.

Klamath Falls is having as difficult a time enacting a dray ordinance as the city of Portland. Our Council has been nearly all winter and up to the present time passing an ordinance to its third reading and now it is on the table. There seems to be some doubt as how far the proposed ordinance reaches. It is the opinion that it would prevent contractors and other parties from hiring teams by the month to do their hauling in the city, unless the teams are licensed. If a man wanted to hire his team he would have to pay a license of \$50 before he would be allowed to do so. This would certainly give the draymen protection.
