RESTORATION TO ENTRY OF LANDS IN NATIONAL FOREST. Its chain of lakes, mountain streams and rivers are matchless among waters of the United States for trout fishing and unsurpassed for water fowl that occupy the marshes as hatching grounds. Waters

the northernmost peak of the Sierras, rears its white crest to an altitude of 14,440 feet. Mount McLaughlin (Mount Pitt) is the highest of the eminences to the north and west, being about 8,000 feet. There is no more attractive steamboat trip on the entire Pacific Coast than that on Upper Klamath Lake with an altitude of 8000 feet above sea level. The lake was first discovered in 1862, and for a long time was called "Lake Majesty," until the more appropriate name it now bears was applied to it. This is one of the places impossible to picture with pen or brush.
