TELEGRAPHIC SUMMARY.

A Boy Murderer. FRESNO, Cal., Aug. 16.—Yesterday afternoon Mrs. Murphy sent her 13-year-old son to stake out a cow near the house. The boy not returning toward night, the mother went out to search for him and found him a short distance from home lying on his face insensible and suffering from a gunshot wound through the head. This morning the boy rallied enough to charge the shooting on a Mexican boy named Enos. Enos has been arrested. Murphy's wound is fatal.

Double Murder. NOGALES, Ariz., Aug. 16.—Two men were killed last night at a railroad camp on the Bisbee road, near Fairbank, north of this city. One man, who had his throat cut, is supposed to have been murdered for the purpose of robbery, and the officers so far have failed to secure any clue that might lead to the capture of the murderer or murderers. The other man was stabbed to death in a general quarrel, but by whom has not yet transpired. Both men were Mexicans.

Bill for Gen. Schofield. WASHINGTON, Aug. 16.—The senate committee on military affairs to-day authorized the chairman to prepare a bill giving to the senior major-general of the army all the rights, privileges and powers that have been employed by the general and lieutenant general when those offices existed. This action is taken to enable Major General Schofield to fill those special assignments which by law fall to the head of the army, and which are not provided for otherwise by the statutes.

A Boodler Lives in Clover. CHICAGO, Aug. 16.—C. S. Gunther of this city has returned from a trip to Bluff, on the Canadian park reservation, where the famous boodler McGarigle of Chicago is now living. McGarigle is now partner of Dr. Bretz in the hotel business. He is a picture of health and is well thought of and quite popular. "I had quite a talk with him," said Mr. Gunther. "He says that his own accounts as warden at the hospital were perfectly straight and he defies the world to find anything wrong with them. He says he was arrested on the supposition that he would squeal on his friends. Rather than testify against them or go innocently to the penitentiary he ran away."

An Old Seaman Brought to Time. WALLA WALLA, Aug. 16.—An old sensation was revived yesterday by the arrest of Wm. Gragg, who ran away with Rosabel, 13-year-old daughter of L. B. North, a Dry Creek farmer, about a year ago. Gragg took the girl to Waitsburg and Dayton on foot, returning her to her parents after three or four days, the pair sleeping in haystacks during their trip. Gragg has been keeping out of the way ever since, but on Wednesday reappeared in the neighborhood, and was at once followed by Mr. North, who corralled him in a neighboring house and compelled him to remain there at the point of a Winchester, until Constable Demars, who had been sent for, arrived and arrested him. Gragg was brought to town Wednesday night and lodged in jail. He was taken before Justice Lambert this morning, waived examination, and was placed under \$500 bonds, which he was unable to furnish, and was sent to jail. Gragg is an old man, and has a wife and grown children.

TELEGRAPHIC SPLINTS.

To-morrow the republicans open the campaign in California by sixty speeches in various places. A new Catholic church in Coleman, Wis., fell in yesterday, killing one man and crushing seven others, several of whom will die. The new law of New York, abolishes hanging for all murderers convicted in that state after January 1, 1889, and substitutes death by electricity therefor. Word comes from Washington that the house unanimously agreed to the fortifications bill. That will give employment to many and tend to reduce the surplus a little. Berthold Greenebaum has been arrested in Chicago for \$29,000 shortage. He was agent for a California wine company, and sold their goods without accounting for the money. Big fires are raging in some of the agricultural districts of California. In the long dry, hot summers vegetation becomes dry as tinder and is easily ignited but with difficulty extinguished. Mrs. Langtry and Freddie Gilhardt were so disarranged by the late railroad accident at Port Jervis, N. Y. which killed their car load of horses and injured their hired men, that it is uncertain when they will resume their journey to California. At the great state fair at Columbus, Ohio, a separate day is to be set apart for a parade and speaking by each of the political parties. Blaine and Fisk have already signified their intention of taking part and no doubt the democrats will also be on hand.

Want the Land. HELENA, Mont., Aug. 16.—The people of the upper Teton section of the territory, mostly in Choteau county, are agitating the question of jumping an immense area of desert land claims, which have been held by non-resident capitalists for speculation for a number of years. This non-resident ownership is preventing the settlement of the country and retarding its agricultural development. There are thousands of acres in this condition, and there seems to be no disposition on the part of the holders to release them from their clutches. The bona fide settlers and business men are getting tired of seeing this vast body of land, which is valuable for agricultural and grazing purposes, lie idle so long, and there is a movement on foot to take possession of it and test the matter in the courts if necessary. The claimants are not residents of that part of the territory, and they have never improved the land, or complied with the laws in any other respect, except to go through the form of proving up. For non-residents to hold such land for speculation is a direct violation of the law, and those who are in the movement to test the matter contend that such claims should be jumped when required for settlement.

Sherrod Williams, eldest son of Gen. Thos. H. Williams, died in Berlin last week. He was well known in Astoria. He leaves a widow residing in this state.
