ELECT A REFORM LEGISLATURE.

The first duty of the people of Oregon is to elect a genuine reform legislature. Jo Simon and his Portland crowd got in two years ago on a platform of specific reforms in the name of the Republican party. They did not present a genuine reform measure that they dare go before the people as such. They run the senate wide open with sham investigations and endless clerkships, spending \$13,500 for clerks to \$3,500 for the house of 60 members where there was an anti-Simon majority.
