"REDEEMED MAN, THE MASTERPIECE OF DIVINE GENIUS AND POWER."

THE SUBJECT OF AN ELOQUENT AND CONVINCING SERMON BY REV. J. K. SMITH AT THE FIRST METHODIST CHURCH CHRISTMAS MORNING, 1898.

Text: Ephesians, 2:10: For we are his workmanship, created anew in Christ Jesus unto good works.

Mr. Smith said in substance, and in part: "In the beginning God created the world—the creatures of the fields, and the air and the seas. He separated the earth from the skies, and set the boundaries of the deep waters.

"Grand as that work was God had only just begun, and it was done. He looked out over the darkness and said: 'Let there be light, and the light thrilled and garlanded and pervaded the universe. All this was a beautiful and convincing exhibition of his divine genius and power, but the grandeur of it was five days preparatory work before the incomparably grander work—the creation of man—the making of a creature in God's own image with dominion over all other creatures—

—Time passes, and the creature, man, so marvelously, wonderfully and beautifully made—falls from his high estate—yes, falls so far, and God's handiwork is so marred and blemished and ruined by sin—the wreck is so complete and irretrievable that it loses, forfeits, all recognition of its former likeness to the Divine Creator. Man has so frustrated the very object and purpose of his creation, namely, God's glory, and his own happiness, that in order to fulfill his destiny he must become a new creature. He must be born again—created anew in Christ Jesus. He is dead in trespasses and in sin. Nothing short of the triple omnipotence of the Father, Son and Holy Spirit, supplemented by the prophets and the martyrs, and all the blessed influences of Christianity can rehabilitate the ruined image. He must be re-created—his nature transformed. He must be born again. He must become a babe in Christ.

"Even the Almighty God seems to have regarded this new work as a test of His limitless power, for He bared His arm to the task, and He said: 'This new creature is God's masterpiece—this new created man who has in himself some part of the life and character of God. This man who is created anew in Christ unto good works.
