THE UNITED STATES census for 1880, shows, there are in Utah, in round numbers, 120,000 Mormons; all other residents, 24,000.

Salt Lake Tribune editorial March 26: "In all the discussions of the effect of the Edmunds bill, it has not been disguised by the advocates of that measure that it was framed and passed for the purpose of transferring the political power in Utah Territory from the Mormons to the Gentiles. It was so stated in the Senate debate, and afterwards reiterated in the House debate on the bill."

THE VOTE for George Q. Cannon at the delegate election on November 2, 1880, was 18,568.

Salt Lake Tribune Editorial, "Figuring Up," March 31st, 1882: "So, then we have three to one against you, Mr. HERALD, and of course you are gone. There's nothing like being accurate in your figures, you see; and the fellow who counts up first is sure to be beaten."

FOLLOWING is the section of the Edmunds law declaring certain persons ineligible for election or appointment to office:

SEC. 7.—That no polygamist, bigamist, or any person cohabiting with more than one woman * * * shall be eligible for election or appointment to or be entitled to hold any office or place of public trust, honor, or emolument, &c.

Below is the oath prescribed by Governor Murray, to which he requires all persons to subscribe before securing commissions:

"I do solemnly swear (or affirm) that I am not a bigamist or polygamist, * * * that I do not live or cohabit with more than one woman in the marriage relation," &c.

PROVISION in the bill of rights in the proposed Utah constitution.

SEC. 4. The right to worship God, according to the dictates of conscience, shall never be infringed; nor shall any person be compelled to attend or support any kind of worship; nor shall any control of, or interference with, the rights of conscience be permitted, or any preference given by law to any religious establishment or mode of worship. No religious test or property qualification shall be required for any office of public trust, nor for any vote at any election, nor shall any person be incompetent to testify on account of religious belief.

On which the *Salt Lake Tribune* of April 26th, comments: "Not only does the section above quoted protect and guarantee polygamy; it does the same for any other sort of religious devilry which may be proposed in the future. * * * Other features of this remarkable document are not much better than this."

SECTION 3 of the Utah school law: "SEC. 3. The trustees shall provide suitable schoolhouses and keep the same in repair, employ teachers, and furnish fuel, maps, charts, and other suitable articles for school purposes, and may at their option collect tuition fees. They shall prescribe the manner in which schools shall be conducted, and the branches to be taught, and rates of tuition therefor, and establish outhouses, playgrounds, and other appurtenances."

Editorial comment of the *Salt Lake Tribune* thereon; May 6th, 1882: "The whole school system is a fraud and imposition, which intelligent people throughout the Territory will be glad to see go into decay."

THE FOURTH.

There ought to be nothing in the way of a whole-souled, joyous celebration of the Fourth of July in this city, a celebration in which all American citizens can take part without thoughts of offending or fear of being insulted. The Fourth is America's bravest and best day, the anniversary of the birth of the republic of which all are proud as being the freest, broadest and best government on earth. The day belongs to no class or creed. There is no party politics or religion in it. It is not even sectional, but extends from the Atlantic to the Pacific, and is the property of all parties, all sects, no sect and everybody. It is the day of the American people, and the man who would deprive anyone of his rights in it is unworthy respect on the occasion, and entitled to no share in the day or the event that will then be commemorated. At times in this city, on the recurrence of the Fourth, all has not been harmony. Distinctive parties have thought the day was their special property, and that only through their generosity and sufferance could others be allowed any interest in it. Happily, if any such feeling does now exist, it does not appear on the surface, and it is hoped it will never again manifest itself to the shame of America and Americans. It is not necessary for men to be of one faith or one party in order to remember and duly indicate their appreciation of the event that we celebrate next Tuesday. When it does come to that condition, then there will be no occasion for any Fourth of July, for what the Fourth achieved will have been lost, and the glory of the republic departed. A most appropriate celebration has been arranged, and while we all participate earnestly and in sincerity, let us hope that the occasion will prove doubly dear to all here in marking the beginning of a broader and better era in Utah, an era in which all will work harmoniously for the advancement, improvement and material and social progress of Utah, and not as has been too much the case in the past, labor against each other, thereby retarding the forward march of the whole. At any rate, let us have a genuine Fourth, whatever the future may be.

A WORKINGMAN tells the Philadelphia Record: "I know when two bosses are running after one man, wages are high; when there are two men running after the one boss, wages are low." That man has mastered the labor question. He has the whole law of supply and demand condensed into a single sentence. If workingmen would commit it to memory, and then be guided by it, and not try to overcome the rule by strikes, their profits would be larger and their troubles less. Wages, like the price of corn and sugar, are governed by a law that cannot be broken as easily as congressional enactments and municipal ordinances. The law may be set aside temporarily, but it will soon reassert itself, and at the end of a brief period it will be found that the results are precisely what they would have been had no attempt been made to change the statute.

THE "SOUTHERN Advance Association" is an organization of Atlanta, Georgia, having for its object the propagation of national ideas, the establishment of free schools, the defending of equal rights and a free ballot box, the promotion of good local government, the breaking down of the barriers between the north and the south, and "the building up of the republican party in the lately rebellious states." This latter seems to be a contradiction of all the first, but as the association has undoubtedly shouldered more than it can carry, the whole load will fall before any progress is made.

THERE is liable to occur a war between Great Britain and Burmah, and all on account of a simple point of Burmese etiquette. A new treaty has been negotiated, and King Theebau agrees therein to the abolition of all trade monopolies, and to accept a British resident, stipulating however that that official shall not appear in his presence with his boots on. The English are unwilling to make this concession, and the relations between the countries are strained.

NOTICE.

Sec. 2207 of the Compiled Laws of Utah is as Follows:

"EVERY PERSON WHO SHALL wilfully and maliciously cut, break or throw down any Telegraph Pole, or any tree, or other material used in any line of Telegraph; or shall wilfully and maliciously break, displace or injure any insulator in use in any Telegraph Line; or shall wilfully and maliciously cut, break or remove from its insulator any wire used as a Telegraph Line; or shall, by the attachment of a ground wire, or by any other contrivance, wilfully destroy the insulation of such Telegraph Line, or intercept the transmission of the electric current through the same; or shall in any other manner wilfully injure, molest or destroy any property or materials appertaining to any Telegraph Line; or obstruct or postpone the transmission of any message over the same; or procure or advise any such injury, interference or obstruction, the person so offending shall be deemed guilty of a misdemeanor."

The Sheriff, and his Agents, in whatever County the Company's lines are constructed, are empowered to prosecute to the full extent of the Law any person or persons found violating the above section, or any part thereof, so far as the property of the Deseret Telegraph Company is concerned.
