

ELKS HOME NOW  
FINEST IN NORTH

The extensive remodeling of Elks' hall which was commenced several weeks ago has just been accomplished. The work has been very thorough creating practically a new interior throughout the entire building. No expense has been spared in getting the desired results. It is now without doubt one of the handsomest and most substantial fraternal buildings on the Pacific coast, certainly the finest in all the North. The building and the land on which it stands is the property of Juneau Lodge No. 420, B. P. O. E. The work that has just been brought to a successful conclusion was done under the direction of the board of trustees of the lodge, at an expense of several thousands of dollars.

**First Floor.**  
The foyer and main entrance have been so completely changed as to be unrecognizable. The entry to the bowling alleys has been closed and a partition built shutting off the stairs leading to the auditorium and lodge rooms of the second and third floors respectively. A second entrance gives access to the stairway. The entrance hall has been somewhat reduced in size but is still ample for the purpose of the lodge and club membership.

**Second Floor.**  
The stairs leading to the second and third floors respectively as well as all hallways have been laid in heavy battismip linoleum. The auditorium has been entirely redecorated. A beautiful new hard maple floor has been laid following a design to improve its condition for dancing purposes. Great steel rod trusses have been placed over the stage span close to the ceiling to relieve the strain from the floor above.

**Third Floor.**  
The third floor is given over entirely to lodge purposes. It contains besides the main lodge room the committee or ante-rooms, a large banquet hall. The entire interior of the floor has been redecorated, refinished and furnished in harmony with the other floors of the building.

**Building Exclusive.**  
Elks' hall has for years been eagerly sought for all of the high class social events by other societies and individuals and has been the public forum for Alaska's capital. It has the honor of housing the first Alaska legislative assembly and other events. Recently however, the lodge adopted a resolution that in future the entire building shall be devoted exclusively to the uses of the Elks' lodge.
