It is now practically certain that the full party of 120 will go on the Alaska excursion arranged by the New Chamber of Commerce for this summer. This trip, as announced some time ago, will be one of the most complete trips through the beautiful and interesting parts of the North. From Seattle the Alaska Steamship Company will furnish one of its fleet, which will go on the inside passage to Skagway, where the passengers will go by train up the White Pass route to Whitehorse, where steamers will be taken down the river to Dawson. From Dawson the party will go down the Yukon to Tanana and Fairbanks. Thence they will go to St. Michaels on the Sarah of the Northern Navigation Company, where they will again take steamer for the Bering Sea, Aleutian Islands and the South Coast. The trip includes 8,000 miles of ocean, river, lake and railroad travel, through the loveliest parts of Alaska at the most beautiful time of the year.—Railway and Marine News.

Ordinance No. 44.

The Town of Douglas, Alaska, does ordain as follows:
Section 1. That Section five (5) of Ordinance No. 43, of the Town of Douglas, Alaska, shall be amended to read as follows:

It shall be the duty of every physician in the Town of Douglas to report within twenty-four (24) hours to the Health Officers of said town, or the Mayor, or any member of the Common Council, every patient that he shall have afflicted with cholera, diphteria, scarlet fever, small pox, measles or other contagious or infectious disease, or any case where the symptoms indicate that any contagious or infectious disease may develop.

Sec. 2. That this ordinance shall be published in the Douglas Island News on the 7th and 14th days of May, A. D. 1913, and copies thereof shall be posted in three public places in the Town of Douglas, and shall take effect and be in force from and after its passage.

San Francisco: In order to complete the Palace of Machinery at the Panama-Pacific International Exposition within the time called for by the contract, 283,000 feet of lumber will have to be put in place in the building each week. During the week ending April 19th the amount of timber added to the structure was 280,000 feet. The probable maximum speed at which the building will be erected before its completion will reach about 350,000 feet a week. At this stage of the construction of Machinery Hall 400 tons of steel have been used in the form of bolts, bars and structural shapes. The heaviest column in the building will weigh 28 tons, the heaviest truss 10 tons. The total length of the building will be about 1,000 feet, the width about 400 feet. Three north and south peaks will be 134 feet high and 120 in the clear.
