#### Alaskan Firms Should File Voluntary Wage **Adjustment Forms**

SEATTLE, July 12-Assurance that War Labor Board enforcement work in Alaska will be conducted with due regard for any extenuating circumstances which are admissible under the wage stabilization policies of the WLB was received here today by John W. Clark of Neill Clark & Co., public accountants, Fairbanks, Alaska.

Clark, representing business firms in Fairbanks, received this assurance in an informal conference with Dr. George Bernard Noble, chairman of the 12th Regional Board, Harold A. Seering, vice chairman, and other board officials.

Pointing out to members of the Board the difficulties and problems faced by many Alaska firms in bringing their programs into line with the WLB wage stabilization policies, Clark declared that many of the firms find themselves in unintentional violation of WLB policies because of lack of knowledge in the Territory of the proper procdures and forms to be fol-

Dr. Noble assured Clark that all such factors would be taken into consideration and advised that all Alaskan firms which have not already done so file voluntary forms for wage adjustments immediate-

"This voluntary filing in itself | faith and will be taken into account in any resulting action,"

If the initial ruling or enforcement action in any wage adjustment case is felt to be unfair, the firm may appeal the decision, Dr. Noble pointed out.

## **Bartlett Says Alaskans Not Dependent People**

WASHINGTON, July 13—(AP)— There's no intention to classify the people of Alaska, Hawaii and Puerto Rico as dependent under the San Francisco charter says Delegate Bartlett in a statement in the Congressional Record.

Bartlett said a New York newspaper article had given the impression that the United States would have to report to the United Nations the condition of the Terriories.

Senator Vandenberg "has rejected any interpretation of the language of the charter which would classify residents of the territories as dependent peoples."

Alaskan residents are residents of the United States in the same sense as residents of the States, said Bartlett.
