As a service to veterans in this area, THE NOME NUGGET will publish a column of the questions most frequently asked contact men of the Veterans Administration in this area.

For more detailed information veterans should contact or write to the nearest VA contact unit at Rooms 46 and 47. Post Office building, Anchorage, Alaska.

Q. I am a step-mother of a veteran killed in service. He was in my care and custody before his entrance in the Army. May I file a claim?

A. Yes.

Q. How long must a National Service Life Insurance policy be in effect before it can be converted?

A. National Service Life Insurance must be in effect at least one year before conversion.

Q. I am training under Public law 16 (Vocational Rehabilitation Act). Does the new legislation limiting combined subsistence and earnings affect me?

A. No. The limitations are placed only on veterans training under Public Law 346 (The G.I.Bill)

Q. I am a widow of a World War II veteran killed in action I have our minor children. Will I be allowed more pension under recent legislation regarding widows pensions?

A. Yes. Before the new Act was passed, there was a ceiling of \$100 for a widow with children for war-time service - connected death cases. Full pension credit, therefore, was not given for more than three children. Under the new law, each minor child will be considered in determining a widow's pension.

Q. What is the National Service Life Insurance Fund?

A. National Service Life Insurance is mutual insurance. All premiums paid on this insurance and all interest earned thereon are deposited in a separate trust fund in the U.S. Treasury, designed as the "National Service Life Insurance Fund." The government derives no profit from its administration and acts in the capacity of trustee o the fund for the sole benefit of the policyholders and their beneficiaries
