VA SUBMITS APRIL **ACTIVITIES REPORT**

Pacific Northwest veterans received 2145 guaranteed loans totaling \$10,187,728 during April, the Veterans Administration reports. Government commitment on the G.I. loans for homes, farms and businesses is \$4,824,818.

More than 62,000 veterans in this area are studying in schools and colleges under G.I. Bill provisions and the vocational rehabilitation act, the report indicated.

At the end of April, no veterans with service-connected disabilities were awaiting VA hospitalization. A total of 3719 veterans were being hospitalized by the the state unemployment compen-VA. 1140 of which were service connected cases.

Disability payments were being made to 71,760 veterans and 10,856 death claims were being paid.

Fishermen Tollin Forecast And Sue Shipowners

SEATTLE, (A) - Halfbut fleet negotiations remained deadlocked Saturday as the deep sea fishermen's union announced plans to file damage suits against the fishing vessel owners' union for lot income from the long tieup since the season's start, May. i.

After a meeting Friday attended by attorneys for both sides, H. E. Lokken, manager of the vessel cwners' group, and E. E. Strom, secretary of the union's executive committee, reported "no progress."

Philip J. Roth, attorney for the union, said damage suits amounting to more than a million dollars will be filed against the vessel owners each this week. He said the actions will charge "unlawful conspiracy to defeat purposes of sation act" because of owners' demands for increased shares of the catch to offset unemployment insurance costs. Lokken called the proposed suits "ridiculous."

The dispute is over owners' demands for a two per cent increase in catch shares.

There's A New Joe Louis Now

MEXICO CITY, (AP)-Joe Louis the world heavyweight boxing champion, has a new son. His name is Joe Louis, Jr., and he's a heavyweight too—11½ pounds when he weighed in.

Joe said he hoped the boy, born here May 28, would become a champion fighter.

"If he's as lucky as I am, he will be," said Joe.

Interviewed on a golf course at San Diego, Calif., after the birth was announced here Friday, Louis disclosed that he and his wife, the former Marva Trotter, were remarried last July in a small Indiana town near Chicago. He could not remember the name of the

Louis and his wife were divorced in Chicago on March 27, 1945, after nearly 10 years of marriage. They have a daughter Jacqueline.

(Continued From Page One sion, in which sviridov said he was unable to comply with a request for the documents because he already had turned the documents over to the Hungarian government and was "authorized" to give them to "the Hungarian government only."

He added that these copies were the only ones in the possession of the Allied control commission--oi which the Americans and British are also members.

The Hungarian coup, which President Truman has called an outrage, was being studied in Washington. The administration is determined to seek full disclosure of Russia's role in the establishment of Budapest's new Communist regime.

Interest centered on the U.S. state department's plan to send a strongly worded note of protest to the Soviet Union against the Hungarian stroke, but in Moscow, the Soviet press made no mention either of the prospective note or of President Truman's comments on the events.

So long as no peace treaty is signed with Austria and the Allied occupation continues, Russia can keep troops in Hungary to maintain communications with her occupation forces in Austria. Retention of such troops conforms with terms of the treaty signed by the Allies with Hungary.
