HANSEN AND WIFE ACQUITTED

Unga People Charged With Criminal Negligence Returning to Their Home.

Andrew Hansen and wife, of Unga, have been acquitted in the district court of the charge of criminal negligence, and were passengers on the Bertha going westward.

Last spring Mr. and Mrs. Hansen went from their home in Unga and left a little child in charge of their older daughter. They were detained from home longer than they had anticipated, and the child died in their absence. A charge of criminal neglect was brought against Mr. and Mrs. Hansen, the daughter being held as the principal witness. They were taken before Commissioner Driffield and the case was then sent to the district court. Their acquittal resulted.

The Bertha arrived last night at 9 o'clock, and sailed two hours later for Seldovia. She expects to make Seldovia and return in thirty-six hours. E. W. Scott, Guy C. Groat, Chas. Steen, and Harry Malone were among the passengers for Seward.

Tom Jones was yesterday brought before Commissioner Reed on a charge of having no visible means of support. He is also suffering from partial paralysis. The judge fined him \$25 and costs. Jones will serve out his sentence in jail.
