REPORT OF THE WORLD'S FAIR COMMISSIONERS.

What purports to be the final report of the Arizona World's Fair Commissioners is published in the Arizona Enterprise of Dec. 24th.

The statement of the disbursements for the mineral exhibit is amply sufficient, however, to prove that a large part of the appropriation was frittered away.

It should be remembered that almost all the ores and minerals displayed were gratuitous donations, and in addition, the Copper Queen Company generously paid half the salary of an assistant at the mineral exhibit during the entire six months of the Exposition.

The cost of the Arizona building is stated at \$3,249.33; furniture and fixtures (five chairs, a desk, table, rug and register, and rented piano, chairs and lounge) \$560.51; maintenance of building \$767.

There was originally appropriated for Maricopa county \$1,040, all of which was expended and not a cabbage stalk or kernel of grain to show for it.

The \$30,000 bonds appropriated by the legislature stand as a debt against the Territory; they run twenty years and draw interest at the rate of 5 per cent per annum...

It is also stated that Tewksbury never pleaded to the indictment; if not, then this is a fatal defect in the trial and must result in the granting of a new trial.

FEDERAL COURTS UNDER STAREDECIS.

By Section 604 of the Revised Statutes of the U. S. (2nd ed. 1878) page 106—the judicial districts of the United States are divided into nine circuits.

The jurisdiction of the circuit courts is such as Congress confers (sewing machine cases, 18 Wall. 577). A general description of the original jurisdiction is that it extends (subject to some limitations founded upon residence) to civil suits involving more than \$2,000...

The District Court of the United States has jurisdiction over all admiralty and maritime causes, all proceedings in bankruptcy, and all penal and criminal matter cognizable under the laws of the United States...
