**POSTPONE EXAMINATIONS**—The regular quarterly teachers' examinations have been postponed until December 23 and 24, announces A. H. Fulton, county school superintendent. Mr. Fulton received instructions from C. O. Case, state school superintendent, to make the announcement. He gave as the reason for the postponement the prevalence of influenza here. The examinations were to have taken place December 2 and 3.

**DAMAGES OF \$10,000 ASKED FOR ARREST**

That I. B. Wood acted maliciously in causing his arrest on the charge of violating the liquor law, is given as the cause for a \$10,000 action for damages instituted in the superior court yesterday by James Logan against Wood.

His humiliation and that of his wife and daughter over the arrest was keen, claims the plaintiff, who declares they were subjected to shame and were unjustly offended by the charge made by Wood.

Wood charged Logan with disposing of liquor in a Wickenburg restaurant and the defendant was brought before Justice W. H. Riggs and acquitted. The fact that he was arrested and imprisoned for one night greatly embarrassed him, alleges Logan. The fact that the arrest was published among the people of Wickenburg gave him added cause for mental suffering, which will be relieved by \$10,000 and \$54.99 counsel fee for the case on which the present action is based.

**THORNE IS CHARGED WITH EMBEZZLEMENT**

E. H. Thorne, traveling salesman of the Morris Packing company, was held to answer to the superior court by Justice Wheeler yesterday on the charge of embezzlement. The defendant did not introduce any evidence, but made the statement that counter claims would be set forth when the matter came up in the higher court.

The charge against Thorne was placed by the company he represents and which he claims is in his debt. The amount involved in the embezzlement charge is but a few hundred dollars.

Thorne was admitted to bail in the sum of \$400.

**SENATOR CLARIDGE TO LIVE IN PHOENIX**

David H. Claridge, who will represent Graham county in the senate in the coming session of the legislature, will become a permanent resident of the Salt River valley.

Senator Claridge in his political capacity has been more or less a Phoenix resident in the past few years, and the fact that he is to live here at all times will be interesting news politically and to the large personal following of the general politician and rancher.

According to word received here yesterday, Senator Claridge has disposed of his farm interests in the neighborhood of Solomonville and has purchased the Brown ranch northwest of Phoenix.

**Lawyers Won't Have to Strain Their Oratory**

Oratory, strained through gauze, has been ruled against in the superior court of Maricopa county.

Upon what is considered to be good and sufficient evidence, Judge Lyman yesterday decided that jury cases in his division of court would not be heard during the epidemic of Spanish influenza in Phoenix.

That the wearing of flu masks was not conducive to brilliant legal oratory was the testimony offered Judge Lyman by attorneys who have had experience in arguing cases in localities where the wearing of flu masks has been compulsory.

The attorneys declared that the feeling of strangulation was so insistent that it was almost impossible to present their cases.

Also the attorneys were of the opinion that the appearance of a bandit, which the lawyers thus disguised presented to the jury, was conducive to hilarity, rather than gravity; and that the jurymen could not closely follow the trend of the argument.

Judge Lyman evidently was impressed with the argument that court could not be satisfactorily conducted under the circumstances.

**BOND ISSUE OF THE HOME BUILDERS IS QUICKLY TAKEN UP**

On November 10 Home Builders' placed on sale \$50,000 of refunding bonds. The new bonds bear 7 per cent interest, running for ten years and are a first mortgage bond secured by improved residence and business property placed in the hands of the Phoenix Title and Trust company as trustee for the bondholders.

The entire issue was oversubscribed, taken entirely by former bondholders or stockholders of the company and with no unusual effort.

Only three of the holders of the bonds refused to accept new bonds and they expressed regret that their business required cash.

When it is taken into consideration that these bonds were offered at a time when there was a big war loan on and the effort being made to raise the big war work funds, it shows how the people who have been connected with Home Builders, appreciate it as an investment.

Home Builders' was organized in January, 1910, and has never failed to pay dividends of 3 per cent to 10 per cent per annum, and has accumulated a surplus of 25 per cent on the common stock.

Home Builders' claim that they have done more towards the building of the many pretty bungalows and substantial homes than any other agency here.

R. H. Greene, the organizer of Home Builders' and its president, says that in the past years since starting building in Phoenix they have constructed more than 200 homes, all of substantial quality, costing from \$1,500 to \$25,000 each.

During the nine months of the present year, just shut down by orders of the war board, they built 24 houses, and had they been permitted to go on with the work they had under contemplation, this would have been the banner year.

Starting with about \$10,000 subscribed by a few of the progressive business men of Phoenix, their growth has been constant. Their assets now amounting to more than over half a million dollars.

Home Builders' is managed by a board of directors of the business men of Phoenix.

**SEARCH IN VAIN FOR ELMO NICHOLSON**

Elmo Nicholson, wanted in two southern states for alleged financial irregularities, cannot be located in the United States, Nicholson, who was safe in Arizona, has made his departure for parts unknown, and a corps of detectives have almost become convinced that he cannot be found.

Nicholson was arrested here a year ago on complaint of leading banks of Arkansas and Missouri. Southern sheriffs came to Arizona to conduct him back to the sunny south, but Government refused to grant for this extradition papers and he remained here. His brother, Charles Nicholson, was not a party to the alleged crime, and furnished his brother funds for legal aid.

When the Nicholson first came to Phoenix they were accompanied by a handsome young woman who posed as Elmo Nicholson's wife. They were accepted by members of the local smart set and when the Nicholson were first taken into custody here it was considered a "grave mistake" on the part of the authorities. The alleged Mrs. Nicholson attempted suicide while in jail, but the slight cut on her wrist, made with a pair of embroidery scissors, did not prove fatal. She left here as soon as released, not waiting the outcome of proceedings against Nicholson.

**WANTS HER CHILDREN BUT NOT HUSBAND**

Claiming that she does not know the whereabouts of her children and that her husband, James C. Bonar, who took them from her, refuses to disclose their whereabouts, Mrs. Josephine I. Bonar has instituted court proceedings for custody of 7-year-old James and Frances, aged five.

In her action for separate maintenance and custody of her children, Mrs. Bonar charges her domestic unhappiness due to her husband's "unbearable temper." She declares that life has become unbearable with the man whose accusations have caused her keen mental suffering. His cruelty has taken the form of jealousy, she asserts, and that he has accused her of being unfaithful to him.

She claims that she is deserving of the care of her two children and asks for their return to her and \$100 a month for her own and the children's support. The Bonars were married in this city in May, 1910.

**ALLEGED FORGER IS RETURNED TO CITY**

A chance arrest made by Deputy Sheriff Joe Bales in Tucson a few nights ago resulted in the Maricopa county officer returning to Phoenix E. W. Barnett, wanted here on the charge of forgery.

Barnett is alleged to have purchased an automobile from McArthur Brothers, passing a bogus check of \$900 and securing in exchange a car and \$100. The alleged sale was unknown to Bales, who en route from the industrial school, remained over in the Old Pueblo for a day or two.

He paid a courtesy visit to the sheriff's office and while there learned that a man 22 miles below Tucson had disposed of an automobile for \$300. The sheriff looked upon the sale with suspicion and requested Bales to join him in the investigation. Not wanted in Tucson, the officers there were about to release Barnett when Bales arrested him, wiring his description to Phoenix. He heard from the local office that a man answering to the description was wanted here for forgery.

Barnett is alleged to have confessed his guilt to Bales, not only having passed a bogus check drawn on a Prescott bank to McArthur Brothers, but also a check of \$56.55 on the Apache garage, where he secured automobile accessories.

When brought before Justice De Souza yesterday he waived preliminary hearing and was held to answer to the superior court. He was unable to furnish bond placed at \$5,000 by the court.

**"BOOZE" CAR CASES NOW IN HIGH COURT**

The automobile confiscation cases were appealed yesterday from the superior court of Pima county to the supreme court. Sheriff J. T. Miles of Pima appears as the appellant. The appellees are defendants who owned the cars which had been captured while conveying intoxicating liquors. In one case the defendant had rented the car to the bootleggers who were using it, and in the other the owner held title to the car, which had been sold on contract.

The status of the defendants, however, had nothing to do with the decision in the lower court, where it was held that the confiscation law itself was unconstitutional in that, being enacted in a special session, it was not such legislation as had been specified in the call for the session.
