Statements attributed to Health Officer J. L. Walker, regarding a need of purifying the water are discussed but even their source was questioned last night. The board is anxious to keep the high standard of the park and accordingly the lagoon will be looked over as it is done at frequent intervals.

FULLER AND M'GEE ARE OUT ON BAIL

Will Appear Against Fallon, Their Former Lawyer

New York, July 17.—Edward M. Fuller and W. Frank McGehee, under prison sentence for bucketing orders of the brokerage firm of E. M. Fuller & Co., which totaling \$3,000,000 in 1922 were admitted to \$10,000 bail each today to allow them to appear in federal court as witnesses against William J. Fallon, their former attorney. Fallon is to go on trial next Monday on an indictment charging bribery of a juror in the trial of the Durrell-Gregory company stock swindling case in 1922.

Admission of Fuller and McGehee to bail automatically stayed their sentence in the state court until they have appeared as witnesses in the federal court. Serving of their sentences had been postponed after their conviction pending completion of the investigations by the federal authorities. For more than a year they have been in prison for contempt of the federal court in failing to produce records of E. M. Fuller & Co. Since last summer they have been prisoners on Governor's Island.

District Attorney Banton, who consented to allowing them bail, indicated that the contempt charge against Fuller and McGehee in the federal court would be dismissed next week. The brokers were sentenced in a state court to serve from three months to four years in prison.

BOGUS OIL SALES

More Than Million Pounds Reported Collected in England by Sale of Worthless U. S. Stock.

London, July 17.—Edward A. Schwab of the American National Vigilance Committee conferred with Chief Inspector Heidon of Scotland Yard yesterday concerning an organization which is alleged to have sold more than 1,000,000 pounds worth of bogus oil shares in Great Britain and the United States.

Schwab has a list of 2,000 persons here who, he claims, parted with nearly half a million pounds. The Daily Mail quotes him as saying that the master brain of the organization is now in London and, with the help of the police, he expects speedily to lay hands on him.

Scotland Yard, however, has suggested to Schwab that this fraud is not an extraordinary offense. Schwab believes that the investigations of the police will convince them to the contrary.

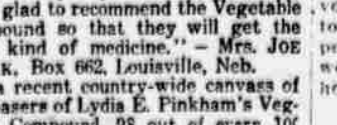
