PADEREWSKI TO PLAY IN THIS CITY
 Great Pianist Selects Wilmington for One of His Concerts
GREAT TREAT FOR LOCALS

A concert by Paderewski in this city is the interesting event announced and assured by the American manager of the famous musician, and Wilmington music lovers will congratulate themselves of the opportunity of hearing in their own city the master who by common consent has been acclaimed as the greatest pianist of the times.
 The engagement will be at the Grand Opera House. The date, November 29, has been held in reserve at the theatre for some months back, although not until the present has it been possible to announce Paderewski's visit here with certainty. He will give but 75 concerts in America from now until next May, appearing twice and at times three times a week. To allow these 75 dates among over 200 cities from which applications for concerts were received was a task which has finally been accomplished by the management, and it may be said that the selection of Wilmington for one concert is due to Paderewski's wish to visit a number of cities where he has not yet been heard. This city's comparatively central location and its easy accessibility to the larger centers also had a bearing in deciding the matter.
 Paderewski will play one concert in Baltimore this week. His New York city appearance is for the afternoon of November 2, and on November 11 he will play at Philadelphia. AFTER PUBLIC FOR ASSISTANCE

The proposition to place Klimentz spring water in the public schools which has been before the Board of Education for two weeks is still under consideration by that body. The question of money is a stumbling block in the way of adopting the system, but the Klimentz Springs Water Company suggests that a popular subscription be taken up and the donations of money be received by the newspapers. The difference needed, to put the water in the schools, the Klimentz Company suggests, be made up by an appropriation from the Board of Education.
 The above proposition was made by the Klimentz Springs Company to Chairman Buckmaster of the health committee of the board. Dr. Buckmaster said the committee had not yet held a meeting on the matter and he reported progress at last night's meeting of the Board of Education.
 The board fixed the time for dismissal in the schools on Friday afternoons for scholars who were perfect in their recitations and attendance during the week at 3 o'clock. Heretofore the time of dismissal was 3.30 o'clock for these scholars.

SPAIN'S KING IN RAILWAY WRECK

CHERBOURG, France, Oct. 29.—The King and Queen of Spain narrowly escaped death or serious injury in an accident to their train near Cherbourg on their way to England early to-day. Though their Majesties were unharmed, widespread comment has been created by the series of mishaps which seem to occur wherever they go.
 The royal party took the train at Paris at midnight for Cherbourg, where they were to board the British battleship Renown, assigned to carry them to England to visit King Edward.
 Just as they were entering Cherbourg the train ran off the rails. To the fact that it had slowed down for the station is probably due the fact that no serious damage was done. The accident has not yet been explained.
