

**Philadelphia Market.**

**THURSDAY, DECEMBER 15, 1836.**

**GRAIN**—Wheat continues in good demand. A cargo just arrived from Hamburg, is held at \$2.20 per bushel. Sales of 3000 bushels good Ohio wheat, New York call, at 2.40—18 to 1400 bushels Pennsylvania, at 2.45, and put delivered at 2.35; some southern new crop at 2.30, and good Wisconsin at 2.25. Bye—Further sales of Omas, at 1.48, 1.50. Some Southern at 1.25. Corn is very dull, and several cargoes of old and new Southern are about unaltered this afternoon. Sales of Pennsylvania from store at 95c 1/2 cent, flat yellow 88 cent at 97c. A sale of superior white in store at 87c. To-day a cargo of old white at 82; a lot of new in good order at 76, and a cargo of new yellow in good condition at 77 cents. Oats, cargo sales of Southern at 49 1/2 cent—beans, sales of 2 3/4 bushels Southern white at \$1.80, 2 per bushel.

**FLOUR AND MEAT**—The flour market remains as at our last report. Receipts light, and demand limited to home use, at \$11 per ton for good brands; New Orleans \$11.75 to \$12.00. Flour from New York at \$7.50 per barrel. Corn Meal—sales of several hundred barrels at \$1.90, and Brandywine at \$2.00 each. Buckwheat Meal—sales in half barrels at \$1.75.

**COAL**—Several thousand bushels Penna. bituminous, will be sold at 25 cents per bushel, on time. Anthracite by retail, has advanced \$1 per ton.

**SEEDS**—Sales of Cloverseed at \$6 to 7 per hundred for common prime quality. Flaxseed at \$1.84, 185, one lot of 270 bushels from Albany at \$1.86 per bushel. Beans—sales of Red Kidney at \$1.80 per bushel, and New Zealand at \$1.80. Killed Pork from wagon sales at \$3.25, 75 per 100 lbs. Butter and Lard are in limited demand at former prices. Cheese is in steady demand at 19 to 11 cents per lb.

**BARK**—The demand for Quercitron has materially fallen off, and prices may be considered something lower.

The following extracts from Professor Hopkins' opinion will enable the public to form some idea of the value and utility of the Metal.

I find the American silver to be composed of the same metals as the Chinese "pak-fong" alloy, which has for a considerable time been imitated in Germany, and sold under the name of "Argentine". All these alloys consist essentially of copper, zinc, and nickel, to the latter of which some trace of iron, tin, lead, and some other properties.

My principal object was to learn whether your metal is safely to be used for culinary and other purposes; and this I suppose is what you are desirous of knowing.

I had several silver spoons washed and exposed for several days to the action of dilute sulphuric, dilute muriatic, and dilute acetic acids, and also to a solution of common salt, and also to a solution of cyanide of potassium, &c. (frequently called in the shops containing the liquor, so as to be immersed to about half their length. At the end of four days, the spoons were as follows: In the salt and water, the metal was not in the least degree tarnished—In the muriatic acid, the metal was much more discolored; in the sulphuric acid, the metal was much more discolored;
